(U) EPSTEIN, JEFFREY [REDACTED]

[REDACTED] 11/03/2006 [REDACTED] was interviewed in [REDACTED] [REDACTED], regarding a federal investigation involving the sexual exploitation of minors. After being advised of the identity of the interviewing agents and the nature of the interview, [REDACTED] provided the following information: [REDACTED] stated that she had been approached by [REDACTED] about providing a massage to JEFFREY EPSTEIN. [REDACTED] stated in December 2004 she was driven to EPSTEIN's residence by [REDACTED]. [REDACTED] advised [REDACTED] that should anyone ask her age, she should say she was eighteen years old. [REDACTED] said that she was never asked her age but that EPSTEIN knew she attended high school. [REDACTED] only went to the EPSTEIN residence on one other occasion. [REDACTED] stated she never received any gifts from EPSTEIN nor had she traveled anywhere with EPSTEIN. Once at the residence, [REDACTED] was taken upstairs to provide a massage to EPSTEIN. She started with EPSTEIN's calves and feet. He later asked [REDACTED] to massage his lower back. EPSTEIN told [REDACTED] to go lower and lower. [REDACTED] told the interviewing agent that she thought to herself, "Oh my God don't say any lower". EPSTEIN told [REDACTED] to go down to her underwear and bra. She did as she was told and thought to her self, "Ok, I knew that". [REDACTED] advised that she knew she may have to remove some of her clothing. EPSTEIN proceeded to turn over onto his back where he exposed his penis. EPSTEIN told her as he unfastened her bra, "we're gonna take this off". EPSTEIN unfastened [REDACTED] bra which had the clasp located in the front. He told her how beautiful she was and that her breasts were beautiful. At one point, EPSTEIN pulled her thong underwear to the side and stroke her vagina. [REDACTED] stated that EPSTEIN inserted two fingers inside her vagina. EPSTEIN commented that [REDACTED] had a "hard clit". During the massage EPSTEIN told her to pinch his nipples. EPSTEIN also licked his hand and stroked his penis. [REDACTED] believed he stopped the massage because he climaxed. [REDACTED] told the interviewing agent that during the massage, [REDACTED] kept thinking, "How am I going to get out of here" and "Please hurry up". [REDACTED] stated that the whole incident "freaked her out". When [REDACTED] and [REDACTED] left the residence, [REDACTED] asked [REDACTED] what had happened. [REDACTED] asked if EPSTEIN had ever touched any of the other girls. [REDACTED]

stated that EPSTEIN had "fingered" one of her other really "hot friends". ██████████ was upset that she had not been told that prior to giving the massage to EPSTEIN. ██████████ never returned to the residence and did not speak to ██████████ again. ██████████ was asked by EPSTEIN to leave her telephone number. ██████████ believed that ██████████ may have giving her number to EPSTEIN or his assistant but they never telephoned her. ██████████ stated that she was sexually active at the time she provided a massage to EPSTEIN. ██████████ said that she was paid \$200.00 by EPSTEIN and he had given her an extra \$100.00 to give to ██████████.
