██████████ (██████████), date of birth (DOB) ██████████, was interviewed via video conference with her attorneys ██████████ ██████████ present. Also present via video was Assistant United States Attorneys ██████████ and Detective ██████████. After being advised of the identities of the above listed individuals and the nature of the interview, ██████████ provided the following information: ██████████ was born in the ██████████. She finished high school then went to college but never finished. She currently lives in ██████████ ██████████.

██████████ recalls that she was at the train with a girl who she went to school with at ██████████ ██████████ was about 15 years old and this was around the summer of 2004. The girl asks ██████████ if she is looking for a job. At the time ██████████ did not have a green card. She tells ██████████ that you give a massage to a guy in your underwear. This girls name is ██████████. ██████████ was from Africa, slim, about 5'6" tall with dark skin and was ██████████ age.

About that day or 2 days later ██████████ and ██████████ take the train to 71 Street between 5th and Madison. They come to a huge house with long brown doors. On the right wall there was a plaque with EPSTEIN's name on it. This is how ██████████ learned his last name. At the time there was some construction on that side of the street. ██████████ is let in by a Hispanic woman. Inside to the left is an office. Inside if the office is pictures of EPSTEIN with CLINTON. ██████████ is taken to the elevator and to the massage room room by the Hispanic woman.

In the massage room there is a table in the middle. There is a shower in the room. There are two chairs on the left of the table. ██████████ sat in a waiting room with a bench prior to getting into the massage room. She waits until EPSTEIN came in. The bedroom is on the same floor as the massage room.

██████████ gets in her underwear and massaged EPSTEIN's legs. EPSTEIN gives them lotion and at some point ██████████ had to leave and sit on ██████████ bench outside and wait for ██████████. Then ██████████ asks ██████████ to come back in. EPSTEIN asks ██████████ to play with his nipples while he jerks off. EPSTEIN pays them \$300 each.

██████████ always tells ██████████ about EPSTEIN and when to go back. A lady used to call ██████████, then ██████████ would call ██████████. ██████████ went back with ██████████ two more times. ██████████ went back until the end of 2005.

██████████ went to EPSTEIN's alone 2-3 times. ██████████ would be sent alone

by [REDACTED]. No one else was ever in the massage room. On one occasion there was a chef who offered [REDACTED] and [REDACTED] carrot cake.

Each time that [REDACTED] went it was mostly the same thing. Once or twice he had them shower afterwards. EPSTEIN always paid.

On one occasion that [REDACTED] went without [REDACTED], EPSTEIN takes [REDACTED] into his bedroom. He carries [REDACTED] into his bedroom after the massage and they had sex. She recalls he had all white sheets. [REDACTED] leaves after this.

EPSTEIN would ask for a blow job. He had a vibrating wand thing he used on their vaginas.

[REDACTED] stopped going eventually and is never given a reason. EPSTEIN asks her if she has freinds that look like her and [REDACTED] says no. [REDACTED] starts getting less calls. [REDACTED] doesn't call [REDACTED] as much.

[REDACTED] never went anywhere other than the New York house and EPSTEIN never took photos of her. To the right of the massage table it looked like there was a camera. [REDACTED] never met anyone else at the house.

[REDACTED] had told her boyfriend and her little sister about EPSTEIN but didn't tell them about the sex.

[REDACTED] tells her sister about the sex with EPSTEIN prior to her calling a lawyer.

[REDACTED] never had spoken to law enforcement prior to this.

[REDACTED] never spoke to the press about EPSTEIN.

EPSTEIN gave [REDACTED] and [REDACTED] Victoria Secret underwear as a gift. He gave it to them when he came back from vacation. It was around the holidays and he gave it to them inside his house. They each got their own gift bags.
