[REDACTED], date of birth (DOB) [REDACTED], was interviewed via video conference with her attorneys [REDACTED] [REDACTED] present. Also present via video was Assistant United States Attorney [REDACTED], Detective [REDACTED] and Special Agent [REDACTED]. After being advised of the identities of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] met JEFFREY EPSTEIN when she was in high school. She came back from [REDACTED] and met a girl named [REDACTED] who introduced her to EPSTEIN. This was around her senior year [REDACTED]. At the time [REDACTED] was attending [REDACTED]. [REDACTED] was going with another girl named [REDACTED]. [REDACTED] tells [REDACTED] that she goes to an older guy to give him a massage in her bra and underwear. He may or may not masturbate and that would be it.

[REDACTED] went to EPSTEIN's residence about 9 times between 2004 and 2005 and stopped going before she finished high school.

The first time she went she recalls going in with [REDACTED]. [REDACTED] thinks [REDACTED] was there in the massage room. EPSTEIN was lying down and on the phone. They all started to massage him and then they left [REDACTED] alone. EPSTEIN then masturbates. He says "you can get your money". EPSTEIN walks out. [REDACTED] gets money from his house lady, a Filipino woman.

[REDACTED] then waited for a call because [REDACTED] gave them her phone number. [REDACTED] or the house lady would call. [REDACTED] met [REDACTED]. She would call [REDACTED] the majority of the times. She would say "EPSTEIN wants to see you, can you come".

On one occasion [REDACTED] told [REDACTED] she couldn't go because she had to stay after school and couldn't come before 5 PM. [REDACTED] says to let her know if she can leave early. [REDACTED] never asked how old [REDACTED] was.

After the first visit [REDACTED] would go by herself or with [REDACTED] or

with a friend [REDACTED].

When [REDACTED] went with [REDACTED] she had left early that day. She took the bus home with [REDACTED] to do a project. They went to [REDACTED] mother's apartment and dropped off their stuff then went to EPSTEIN's. [REDACTED] came to the house but did not go into the massage room.

[REDACTED] recalls bringing a childhood friend of hers named [REDACTED] once. Someone had suggested to [REDACTED] to bring a friend. EPSTEIN asked [REDACTED] to bring more people. He asked for girls [REDACTED] age or younger. [REDACTED] had told EPSTEIN that she was 16 years old when she first met him. EPSTEIN's cleaning lady knew [REDACTED] age and knew what school she went to and knew when she was graduating. She knew when she got out of school. All the girls were the same age. [REDACTED] started to see EPSTEIN but not with [REDACTED].

[REDACTED] asked [REDACTED] on the phone if her friend [REDACTED] was in school with her and how old she was. They were interested in [REDACTED]. [REDACTED] called [REDACTED] to ask about [REDACTED]. [REDACTED] had said to [REDACTED] that he wants young girls.

[REDACTED] went there about 9 times and it was generally the same thing each time. It was a massage and EPSTEIN would masturbate and ejaculate. Sometimes he would get more physical depending on his mood. For example he would jump off the table, come behind [REDACTED] and touch her and try more sexual activities. He would bite her neck or shoulder. When he was done he usually just got up and walked out. The money would always come from the cleaning lady. She got paid \$200. She may have gotten paid \$300-\$350 when she brought [REDACTED].

[REDACTED] felt like it was a competition for money between her friends. They would sometimes get calls to come separately.

EPSTEIN gave [REDACTED] a purse as a gift once. The gift was given to [REDACTED] by the cleaning lady. [REDACTED] sells the purse around the holiday time. [REDACTED] never received anything else from EPSTEIN.

[REDACTED] had a nokia phone back then. Her phone number may have been [REDACTED]
[REDACTED]

No other persons were ever in the massage room other than [REDACTED] friends. [REDACTED] never discussed what happened in the massage room with either [REDACTED] or the cleaning lady.

EPSTEIN's house was on either on 71 street or 73 street near 5th Avenue near the park. [REDACTED] never saw EPSTEIN outside of his house.

[REDACTED] saw MAXWELL at his house twice. The first time [REDACTED] met GHISLAINE MAXWELL she was there talking to another unknown girl with long

blonde hair. [REDACTED] said "that's Ghislaine". [REDACTED] was invited to a dinner party at EPSTEIN's house. She was told it would be a fun foot party. [REDACTED] couldn't go and didn't talk personal details.

Photos were never taken of [REDACTED].

The second time [REDACTED] see's MAXWELL at the house she just said hello.

[REDACTED] partner is the reason why she stopped seeing EPSTEIN. She had told him that she was massaging an older guy in her bra and underwear. He said that he does not want her seeing this man anymore. [REDACTED] recalls that she started seeing EPSTEIN around when she was 16-17 years old. At 18 she had stopped seeing him.

For about a month or two they called to ask [REDACTED] to come back. She ignored the phone calls.

[REDACTED] never talked to law enforcement about EPSTEIN.

[REDACTED] told a few classmates pieces of what she was doing with EPSTEIN but never the whole truth.

About two years after seeing EPSTEIN, [REDACTED] tells her mother about what happened.

[REDACTED] never talked to reporters about EPSTEIN.

[REDACTED] told [REDACTED] that EPSTEIN was mean to her one time.

[REDACTED] started going to the island with EPSTEIN which [REDACTED] finds out later.
