



## FEDERAL BUREAU OF INVESTIGATION

██████████, date of birth (DOB) ██████████, was interviewed at 1 St Andrews Plaza New York NY. Present for the interview was AUSA ██████████, AUSA ██████████ and ██████████ Attorneys ██████████ and ██████████. After being advised of the identity of the interviewing Agents and the nature of the interview, ██████████ provided the following information:

██████████ recalled JEFFREY EPSTEIN saying something about an investigation in late 2005 or early 2006. EPSTEIN told ██████████ that there was a woman in ██████████ that had been arrested on drug related charges and gave information on going to EPSTEIN's for massages. EPSTEIN said women lied to him about their ages. ██████████ advised that there were many occasions when EPSTEIN said women were trying to blackmail him.

██████████ advised that there were photos taken out of EPSTEIN's Florida and Paris residences. The photos were of naked women. ██████████ does not recall exactly when the photos were taken down. ██████████ did not recall noticing any changes to the 71st Street (NY) residence or a the ranch (New Mexico). ██████████ advised that it was a bit stressful during this time, EPSTEIN did not want anyone discussing things. ██████████ was interviewed by EPSTEIN'S lawyers regarding experiences with other women in ██████████. ██████████ was very protective of EPSTEIN at that time, and probably said things that were favorable to EPSTEIN. ██████████ recalled meeting with EPSTEIN's lawyers in New York and at another location where he owned a residence. The lawyers advised her not to talk to anyone before she got a lawyer. EPSTEIN suggested ██████████ not talk to the press.

██████████ spent most of the time during EPSTEIN's prison sentence in Palm Beach, so that she could be there for visitation. ██████████ would visit EPSTEIN approximately twice a week while he was incarcerated. For the first few months of this sentence ██████████ only visited him in jail. Once EPSTEIN was allowed out on work release he put ██████████ ██████████.

[REDACTED]. [REDACTED] advised that EPSTEIN would ask his lawyer, DARREN (known to the FBI as DARREN INDYKE) and paralegal, STORY, to bring him a laptop when they visited him in jail. EPSTEIN asked [REDACTED] to have sex via webcam on more than one occasion while he was in jail. [REDACTED] did not believe anyone else was in the room at the time.

After EPSTEIN had an office space rented in West Palm Beach, Florida, [REDACTED] (known to the FBI as [REDACTED]) and [REDACTED] were asked to set it up. [REDACTED] advised that EPSTEIN's pilot, LARRY, STORY and EPSTEIN's house manager were all helping set up his office. [REDACTED] believes EPSTEIN told her that she could not be in his office while he was there. [REDACTED] met him for lunch regularly and they would sit in a park downstairs. EPSTEIN had different assistants working out of that office during this time, to include; [REDACTED], [REDACTED], [REDACTED] and STORY. In the morning's EPSTEIN was driven by EGOR ZENOVIA and [REDACTED] would drive EPSTEIN back at night. EPSTEIN had a suburban outfitted with a mattress in the back where [REDACTED] and EPSTEIN had sex while the car was parked in the prison parking lot. [REDACTED] recalled flashlights in the parking lot, but no one ever came over to the car. [REDACTED] did not recall filling out any paperwork or interacting with guards [REDACTED] EPSTEIN. [REDACTED] recalled EPSTEIN having people with him while he was on work release, but she was not sure if they were bodyguards or associated with the jail. [REDACTED] recalled a prank where a sheriff came to the West Palm Beach residence to tour and EPSTEIN was hiding on the toilet off of the massage room. [REDACTED] was in on the prank. [REDACTED] believed someone videotaped the prank. EPSTEIN was friendly with one prison guard. [REDACTED] recalled this guard came over for lunch and there was talk about him getting a job through EPSTEIN.

[REDACTED] first met EPSTEIN in mid 2004, possibly in May. [REDACTED] had never been part of a threesome at that point. [REDACTED] was studying for the GED exam. EPSTEIN told [REDACTED] that if she didn't pass her GED she would have to do a threesome. [REDACTED] passed her GED. [REDACTED] was traveling with [REDACTED] and EPSTEIN at that time and became [REDACTED] roommate. That Christmas EPSTEIN gave [REDACTED] and [REDACTED] sex toys. [REDACTED] advised she and [REDACTED] had just turned 18. There was an ongoing joke that [REDACTED] would "get" [REDACTED]. [REDACTED] and [REDACTED] had a sexual

encounter in New York and when EPSTEIN found out he wanted to have a threesome. [REDACTED] ultimately agreed to a threesome. [REDACTED] was at the West Palm Beach house and [REDACTED] came into the massage room. [REDACTED] was topless and had her nipple pierced. EPSTEIN wanted them to massage him. EPSTEIN directed [REDACTED] and [REDACTED], he had them kiss as touch. [REDACTED] felt like the newcomer with the least experience. [REDACTED] had the sense that [REDACTED] and EPSTEIN had sexual experience together before. [REDACTED] believed [REDACTED] was from [REDACTED]. [REDACTED] never traveled with [REDACTED] and EPSTEIN. [REDACTED] saw [REDACTED] in the massage room in Florida approximately 3-5 times.

On one occasion [REDACTED] went shopping at an adult video store with [REDACTED] and recalled [REDACTED] being asked for I.D. [REDACTED] advised that [REDACTED] I.D. state that she seas over 18. [REDACTED] knew [REDACTED] was in her last year of high school and EPSTEIN was going to help [REDACTED] get into [REDACTED]. EPSTEIN had asked [REDACTED] to write an essay, which she never did and EPSTEIN took his offer back on helping her get into [REDACTED]. [REDACTED] advised that in [REDACTED] people are 18 or 19 years old during their last year of high school. [REDACTED] now believes [REDACTED] was 17 at the time. There were occasion when [REDACTED] and [REDACTED] would go into the massage room together and times when EPSTEIN would send [REDACTED] out and end encounters with just [REDACTED] in the room. [REDACTED] doesn't remember seeing [REDACTED] receive any money at the house.

[REDACTED] advised that [REDACTED] and other staff would set up the massage room. At the beginning or end of trips, EPSTEIN would put cash (always \$100 dollar bills) in [REDACTED] purse. Sometimes EPSTEIN would give [REDACTED] money for her and [REDACTED].

[REDACTED] recalled having sexual encounters with three different women in [REDACTED]. These women were [REDACTED], [REDACTED] and [REDACTED]. [REDACTED] had encounters with [REDACTED] and [REDACTED] on one or two occasions separately. All encounters happened in the West Palm Beach house, mostly in the massage room. [REDACTED] recalls one encounter, she was not sure with which girl, that happened in the bedroom. [REDACTED] described that usually she would walk into the massage room, EPSTEIN would be on the phone, he would turn over and request what her wanted done. EPSTEIN would orchestrate the girls, telling them where to stand. Once EPSTEIN reached orgasm, he would send [REDACTED] out of the room and the other girl would stay in the room getting

dressed.

[REDACTED] did not recall walking [REDACTED] or [REDACTED] up to or down from the massage room. [REDACTED] recalled approximately 1-2 women per day would go to the massage room. [REDACTED] advised that it was always women, she only recalled one man waiting in the kitchen. [REDACTED] believed the girls were around her age at the time. [REDACTED] recalled the names, [REDACTED] (known to the FBI as [REDACTED]), [REDACTED] and [REDACTED] as having come to the massage room. [REDACTED] came multiple times. [REDACTED] advised that there were more girls that she doesn't remember the names of. [REDACTED] believe that the girls were scheduled by appointment and/or brought there by friends. [REDACTED] stated that someone would let the girls in and walk them upstairs. [REDACTED] recalled the names of EPSTEIN's assistants, [REDACTED], [REDACTED] (known to the FBI as [REDACTED]) and [REDACTED] (known to the FBI as [REDACTED]). [REDACTED] heard of saw EPSTEIN's assistant scheduling appointments for the girls. [REDACTED] advised it was not her role to schedule appointments, but may have reached out to [REDACTED] at some point. [REDACTED] rarely answered the phone at the [REDACTED] residence. Usually the calls were for EPSTEIN or GHISLANE MAXWELL. Over time EPSTEIN did not want [REDACTED] answering the phone. [REDACTED] advised that it was possible that she answered the phone and left voicemails.

Initially [REDACTED] wasn't sure what would go on inside of the massage room. [REDACTED] though that EPSTEIN was just getting massages. [REDACTED] advised that there were women that would give EPSTEIN normal massages, to include MAXWELL, [REDACTED], and [REDACTED]. [REDACTED] also knew [REDACTED] (known to the FBI as [REDACTED]), [REDACTED] and a woman with tattoos gave normal massages to other people. [REDACTED] was a few years older than [REDACTED]. [REDACTED] and the woman with tattoos were also older. [REDACTED] was unsure if these three women were there for sexual motives or just performed normal massages. [REDACTED] believed EPSTEIN was getting massages before she first met him. Before EPSTEIN went to jail the massages slowed down and ultimately stopped. [REDACTED] could not recall specific timing. [REDACTED] advised that it mostly occurred in [REDACTED].

In New York [REDACTED] lived separate from EPSTEIN. [REDACTED] knew that EPSTEIN had massages in New York, but she wasn't normally at his residence during the day. [REDACTED] recalled a blonde, Russian woman she and EPSTEIN had a threesome with in his New York residence master bedroom. [REDACTED]

did not go the the New York residence massage room with Epstein often, she recalled it happened approximately twice.

On EPSTEIN's island, [REDACTED] believed most of the women were from New York. [REDACTED] named [REDACTED], [REDACTED], [REDACTED], [REDACTED] and others she could not recall. [REDACTED] was part of a sexual encounter with [REDACTED] in EPSTEIN's bedroom on the island. A woman named [REDACTED], was also part of a sexual encounter with [REDACTED] and EPSTEIN on the island. [REDACTED] advised that [REDACTED] later worked in EPSTEIN's office.

[REDACTED] did not recall any instances from the New Mexico Ranch. [REDACTED] advised there was a woman with long dark blonde hair that would come around in Paris. [REDACTED] believed this woman was older than she was.

In the interest of time, not all subject matter was covered during this interview.
