██████████, date of birth ██████████, was interviewed telephonically on 7/15/2020. Present on the call was ██████████ attorneys ██████████. After being advised of the identity of the interviewing Agent and Analyst and the nature of the interview, ██████████ provided the following information:

██████████ did not recall who brought her to meet JEFFREY EPSTEIN or how it came about that she first heard of him. ██████████ was 14 years old when she first met EPSTEIN; she was told there was a guy who liked to talk to younger women. Someone, either a girl or woman, told her something like, "If you want to talk to this guy, he's a great listener and likes to gift." ██████████ was given EPSTEIN's address and took the train by herself. ██████████ remembered ringing the doorbell. At the time, ██████████ had a lot of things going on at home. ██████████ became friends with EPSTEIN; she would go to his home and sit and talk with him in his office/library/ study. EPSTEIN and ██████████ would talk trade, stocks, and money.

A couple months after knowing EPSTEIN, he asked ██████████ if she minded giving him a massage. ██████████ told him it was ok. EPSTEIN picked an oil and started a conversation. ██████████ felt that it was casual as she rubbed his feet and back. One day, everything changed as EPSTEIN took a little vibrator out and used it on ██████████. EPSTEIN bent ██████████ over the table and penetrated her. When ██████████ would continue to go to EPSTEIN's home, the same thing would happen when she went. This would happen when EPSTEIN took her to his personal bedroom and the massage room.

██████████ went to EPSTEIN's home two to three times a week from the

time she was 14 years old to 18 years old. When she would arrive, [REDACTED] would ring the keypad and a butler would let her in. [REDACTED] would be greeted by a woman, who would bring her to the office. [REDACTED] described the study/library area would be to the left side and she would read books sometimes. EPSTEIN would be at his desk and she would have to wait until he was finished. A woman also brought [REDACTED] to the massage room. [REDACTED] described the massage room as having red velvet curtains. [REDACTED] thought she recalled EPSTEIN's bedroom as having baby blue ceilings that looked like cathedral type ceilings.

[REDACTED] interacted with two different women who would greet her on different occasions. [REDACTED] described the two women as one with blonde hair and one with dark "boy cut" hair. The blond woman would just ask how her day was going. [REDACTED] only saw the women in the beginning when she arrived. [REDACTED] stated these women were clearly not in their twenties, meaning they were older. The women always greeted [REDACTED] by her name.

In the beginning, the dark-haired woman would tell [REDACTED] what a great guy EPSTEIN was and that [REDACTED] could confide in him. The dark-haired woman would take her to the massage room and tell her to undress and wait. Then the dark-haired woman became very short and to the point. It seemed to [REDACTED] that the dark-haired woman knew what was going on as the woman had told her to undress. The dark-haired woman would take [REDACTED] to the office then to the massage room. [REDACTED] recalled taking an elevator to go upstairs then from the elevator to the massage room was a short walk.

Before the rapes, the dark-haired woman would justify EPSTEIN as being a great guy who would be there for her. She always spoke EPSTEIN up. After the rapes, the woman became more "mechanic" where she would just take [REDACTED] to the room and tell her it was ok to undress if she wanted. The dark-haired woman made [REDACTED] feel like it was all a normal thing.

Every time [REDACTED] saw EPSTEIN, he gave her money. It was always EPSTEIN who gave her the money; he gave her \$300 and would say something like, "Here's a little something for you." [REDACTED] did not have much

money. Her mother was a housekeeper and her father worked in restaurants. EPSTEIN knew her family's situation.

EPSTEIN sent [REDACTED] gifts on Christmas. EPSTEIN sent her jewelry, perfume, and a cashmere scarf. EPSTEIN wanted to know where she was living at any given time so he could send gifts to her.

[REDACTED] always saw EPSTEIN barefoot and in a T-shirt.

Later on, in her time with EPSTEIN, he would call [REDACTED] personally. [REDACTED] thought this happened two, three, or four times. Usually, [REDACTED] received a call from a female voice who would be calling to schedule. While [REDACTED] was at EPSTEIN's house, he would schedule another day for her to come over; sometimes being the day after she was just there.

The only other person who knew about her going to EPSTEIN's home was the person [REDACTED] brought to EPSTEIN. Before EPSTEIN had done anything sexual to [REDACTED], she brought a girl. EPSTEIN had asked [REDACTED] if there were other people, she knew that would want to talk with him. [REDACTED] brought her friend, who EPSTEIN raped. [REDACTED] thought she had stayed downstairs while her friend was with EPSTEIN. When her friend came downstairs, she did not want to talk to [REDACTED]. [REDACTED] and her friend disconnected after this happened and [REDACTED] did not know what had happened to her friend until recently. [REDACTED] holds so much guilt for having brought her friend, [REDACTED].

It started by EPSTEIN and [REDACTED] just talking in the office. Then, EPSTEIN asked if she would like to see his massage room. At the time, [REDACTED] confided in EPSTEIN and believed and thought it was ok. [REDACTED] thought why would he do the things he did to her if it was not ok.

Towards the end of her time with EPSTEIN, he introduced her to a man named BRUCE LNU (last name unknown). BRUCE had an apartment in New York City, which [REDACTED] recalled being full of Mickey Mouse stuff. [REDACTED] recalled BRUCE having a tan line where his wedding band would have been. EPSTEIN told [REDACTED] to go meet his friend and have dinner with him. BRUCE wanted to do something else. [REDACTED]

recalled EPSTEIN would say be a "good little girl".

[REDACTED] recalled EPSTEIN's home having old fashioned décor. A butler would take her to the room on the left and get her something to drink. [REDACTED] recalled there being "like three walls of books". There were old style reading chairs that reminded [REDACTED] of chairs out of *Beauty and the Beast*. The dark-haired woman and blonde woman told [REDACTED] that she was welcome to take a book if she wanted - she did not keep the books.

EPSTEIN always walking in from the left side doorway into the room. EPSTEIN would walk [REDACTED] out with his hand on her shoulder.

[REDACTED] recalled at one point loving EPSTEIN, feeling like she was special. [REDACTED] felt the way she is today was because of how EPSTEIN groomed her.

[REDACTED] did not want to go into all the details about the abuse; not all details were covered during the course of this interview.
