██████████, date of birth ██████████, was interviewed over the phone by Special Agent ██████████ and Detective ██████████. Also present on this phone call was ██████████ attorney ██████████. After being advised of the identity of the interviewing Agents and the nature of the interview, ██████████ provided the following information:

██████████ met EPSTEIN at 17 years old. She recalls it was ██████████ and it was warm out. She was asked to give him dance inspired work outs which morphed into massages in her underwear. This happened about 3-6 times for the first few years. These morphed into sexual arrangements. He controlled a lot of her life. EPSTEIN asked that ██████████ not go to college and make different career choices. He kept her from going back to school. He asked ██████████ to introduce him to other friends of hers.

The first meeting of EPSTEIN started when ██████████ was coming out of ballet class in New York "██████████". Someone asked ██████████ if she wanted to give EPSTEIN dance inspired work outs. ██████████ does not recall this person's name but she was tall, blonde and pretty.

██████████ goes to EPSTEIN's house about the next day. She talked with the woman who gave her directions to his house. She meets them at the house. There was a cleaning staff and doorman at the house. ██████████ met PRINCE ANDREW and a brunette there. She waited in the lobby area. EPSTEIN either met her downstairs or in the gym. No one else was in the gym. It was just a flirtatious work out at first. He asks for ██████████ to come back the next day and pays her \$100.

██████████ is not sure if they exchanged numbers. The original woman she dealt with may have handled that. Additional meetings were scheduled by either EPSTEIN or his assistants. His assistant's name was ██████████. After the first 1-2 sessions with EPSTEIN they turned into massage sessions. The

sexual activities started between the 2-4th session.

[REDACTED] saw EPSTEIN around 2010 after he got out of jail. The first 3-4 years she saw him a lot. After that it slowed down to less than once a month. During the massage it would range anywhere from masturbation to penetration. EPSTEIN always wanted to know what [REDACTED] was doing with dance and her professional life. They would talk about [REDACTED]. Then in the massage room things heated up. He would tell [REDACTED] what to do. Then he would push her around to get him to do what he wanted to do. He would continue to pay [REDACTED]. The girl would call [REDACTED] and say \$100 for massage with clothes on and \$300 for massage with clothes off.

Sometimes EPSTEIN would pay [REDACTED] more if she was well behaved. He paid for auditions. He would pay directly for these auditions. He would send [REDACTED] to hair salons and to get clothes.

Sometimes there were other girls in the room. Once there was a girl named [REDACTED] who was a tall blonde. This was his "main [REDACTED]".

A number of different people called [REDACTED] but she does not know the names.

EPSTEIN asked her to go to Paris which she did not. EPSTEIN sent [REDACTED] to London and Florida for auditions. She did not see him in Florida. His driver may have picked her up. EPSTEIN was trying to court a friend of [REDACTED] at the time. The driver may have been following them around while they were down in Florida. [REDACTED] saw him at a distance a few times.

[REDACTED] turned 18 on [REDACTED]. She was born in [REDACTED]. Sexual encounters with EPSTEIN happened prior January 2004.

[REDACTED] met JEAN-LUC, FREDRICK PACKIE and PRINCE ANDREW. She also met other unknown persons. She met [REDACTED] (the [REDACTED] she spoke about earlier), [REDACTED], [REDACTED], [REDACTED], [REDACTED] and a [REDACTED]. [REDACTED] does not know their ages.

At the time [REDACTED] first met EPSTEIN she had just moved to New York with no money. He knew that and used that to help her and also get what he wanted.
