██████████, date of birth (DOB) ██████████, was interviewed at ██████████. Present for the interview was ██████████ attorney ██████████, along with AUSA ██████████, AUSA ██████████. After being advised of the identity of the interviewing Agents and the nature of the interview, ██████████ provided the following information:

██████████ provided items that she had kept from the time period she was going to JEFFREY EPSTEIN's house. Items included an old flip phone used during that time period. ██████████ thought she had used the phone approximately in 2002/2003. ██████████ corrected herself when she showed a receipt from her purchase of the phone that showed a 2004 purchase date of the phone. ██████████ also brought a phone that she had purchased later that had ██████████ and ██████████' (Also known as ██████████) phone numbers in it. These numbers had been transferred over from her flip phone. ██████████ also provided photographs, receipts, and a notebook.

██████████ opened her silver LG flip phone to display the numbers stored in her phone. ██████████ stated she bought this phone with the money she received from EPSTEIN. [Agent note: screenshots were taken of the phone of ██████████ and ██████████ contact numbers, along with the device's information and contact number.]

The photographs ██████████ provided were taken approximately from 2001 to 2004. The smaller photographs were senior pictures that would have been taken in ██████████; in one of the photographs, ██████████ was in a black jacket and this photograph was one she had given to EPSTEIN. The larger photograph with ██████████ in a green shirt was taken when ██████████ was in 10th grade. The other larger photographs were taken in approximately 2003. During that time frame, ██████████ was in a modeling camp. ██████████ was in modeling camp before and during the time she went to EPSTEIN's house. The cheerleading photographs were taken the

fall of [REDACTED] freshman year in approximately [REDACTED]; [REDACTED] was not going to EPSTEIN's at this time.

[REDACTED] provided bank deposit receipts, along with a notebook that detailed dates she deposited \$200 into the bank, along with written descriptions of EPSTEIN's house, copies of receipts, and copies of [REDACTED] school planner where she had written in EPSTEIN's name and stored [REDACTED] phone number.

[REDACTED] talked about the times she went to EPSTEIN's house. The first couple of times she went, someone told her and showed her what to do. [REDACTED] and her friend [REDACTED] (known to law enforcement as [REDACTED] [REDACTED]) went together to make her feel comfortable. [REDACTED] thought that EPSTEIN came into the room in his clothes. [REDACTED] thought that she may have been in just her underwear but she was unsure. [REDACTED] friend showed her what to do during the massage, then her friend left the room. [REDACTED] continued the massage. [REDACTED] thought EPSTEIN was first on his stomach then turned over to his back. [REDACTED] stated that it would start as a normal massage, then EPSTEIN would want her to play with his nipples, while most of the time he was masturbating. EPSTEIN touched [REDACTED] "all over."

EPSTEIN used sex toys on [REDACTED]. [REDACTED] would tell EPSTEIN that she was on her period so she did not have to take off her underwear. EPSTEIN used a vibrator on [REDACTED] genital area. EPSTEIN used the vibrator when she was wearing underwear; [REDACTED] did not wear her underwear every time that EPSTEIN used a vibrator on her. EPSTEIN did not put the vibrator inside her. EPSTEIN also touched [REDACTED] genital area with his fingers. [REDACTED] stated that EPSTEIN may have penetrated her vagina with his fingers but was unsure.

[REDACTED] brought two girls, [REDACTED] and [REDACTED], to EPSTEIN. Both [REDACTED] and [REDACTED] were approximately 16 or 17 years old at the time. [REDACTED] remembered that she brought [REDACTED] and [REDACTED] around approximately October 2004 because it was around the time that hurricane passed through Florida. [REDACTED] was a couple months younger than [REDACTED]. [REDACTED] "had big boobs." EPSTEIN asked [REDACTED] to bring [REDACTED] back. [REDACTED] [REDACTED]. [REDACTED] was a couple of months older than [REDACTED]. [REDACTED] described [REDACTED] as approximately [REDACTED] she may have had blonde or brown hair. [REDACTED] was awkward and uncomfortable. [REDACTED] and [REDACTED] went in together then [REDACTED] sat outside and sun bathed while she waited for [REDACTED]. [REDACTED] came out to get [REDACTED] and [REDACTED] had to go back into

the room with EPSTEIN. EPSTEIN told [REDACTED] not to bring [REDACTED] back. [REDACTED] only went the one time.

EPSTEIN told [REDACTED] to bring "pretty girls." [REDACTED] did not recall if those were his specific words but she recalled him telling her something along those lines.

EPSTEIN told [REDACTED] that when she was 18 years old he would take her on his plane. [REDACTED] did not remember why EPSTEIN told her that she had to be 18 years old.

EPSTEIN had "Bath and Body Works" lotions. [REDACTED] recalled that the lotion was "some lavender disgusting smell."

[REDACTED] and [REDACTED] have not recently talked about EPSTEIN. [REDACTED] recalled that in approximately 2005/2006, [REDACTED] sent her a private message apologizing for bringing her to EPSTEIN.

[REDACTED] talked with [REDACTED] about EPSTEIN when [REDACTED] was first approached by the FBI in the mid-2000's. [REDACTED]
