[REDACTED], date of birth (DOB) [REDACTED], was via video conference. Present on the video call was [REDACTED]. Also on the video call was [REDACTED]. After being advised of the identity of the interviewing Agent and the nature of the interview, [REDACTED] provided the following information:

[REDACTED]. A woman walked in towards the end of the class and tried to make eye contact with [REDACTED]. After the class, the woman came up to [REDACTED] and asked her if she did at home stretching. The woman said something like, "I'm going out of the country but my boss is looking for light stretching." The woman told [REDACTED] that someone would call her. Someone called [REDACTED] and told her his name was JEFFREY (EPSTEIN).

[REDACTED] was 22 years old when she went to EPSTEIN's home. A shorter man, with dark hair, who appeared to be a young butler, answered the door. He took [REDACTED] to the left to an office to wait. EPSTEIN came in and asked [REDACTED] what she did for work. [REDACTED] told him she was trying to get into modeling. EPSTEIN told her that he had some financial dealings with VICTORIA'S SECRET. EPSTEIN also talked with [REDACTED] about the ballet, GISELLE and he made it seem like he had something to do with it.

EPSTEIN then said, "Let me see you...stand up". EPSTEIN told her she was "bottom heavy". It was an abrupt end to the conversation. EPSTEIN told her he would schedule a time for her to come back.

When [REDACTED] came back to the residence, she went in an elevator to EPSTEIN's private gym. [REDACTED] described the gym as having pictures all over the walls of naked women. [REDACTED] found it hard not to comment. EPSTEIN told [REDACTED], "I took all the pictures at my private island and these are my employees". EPSTEIN further stated that it was a private island and people did not need clothes there. EPSTEIN told her if she was a good girl he would take her there. [REDACTED] showed EPSTEIN some stretches and he gave her \$100. [REDACTED] thought she was maybe there for 45 minutes. There had been no discussion about money and [REDACTED] recalled getting the \$100 and thinking "great".

[REDACTED] went back to EPSTEIN's residence on a different day and went up to the gym. When [REDACTED] was stretching EPSTEIN, he became "handsy". EPSTEIN put his hands on [REDACTED] legs. EPSTEIN then stood up quickly and they walked down the hall to a room that had a massage table. EPSTEIN told her he would give her \$300 to massage him. [REDACTED] told EPSTEIN she was not a masseuse. The door was shut and [REDACTED] was nervous and did not know where to go. EPSTEIN pulled off his pants and shirt and laid down naked on the table. [REDACTED] rubbed his back and EPSTEIN tried to reach around and grab her buttocks. EPSTEIN then stood up and put a towel on, telling her, "Let's have some fun". EPSTEIN took out a camera and said, "Let's take some pictures of you". EPSTEIN made it seem like it was for modeling. EPSTEIN told [REDACTED] to take off her shorts, which left [REDACTED] in her tank and underwear. [REDACTED] was nervous. EPSTEIN went over towards her and pulled her shirt down. [REDACTED] told him no and that she did not want to do that. EPSTEIN again pulled her shirt down. [REDACTED] did not remember how she got out of the room.

[REDACTED] recalled it was always the same woman from a private number who called her to schedule her to go to EPSTEIN's New York residence. A woman also called [REDACTED] to tell her that EPSTEIN wanted her to go to his island. [REDACTED] told her that she could not make it. Sometime later, she called again. [REDACTED] kept answering the calls because her boyfriend also had a private number.

In the spring, when [REDACTED] was 23 years old [REDACTED], a woman approached her and asked to get her number for personal training at home. On a different day, the same woman said to her, "Oh I think you know my boss, JEFFREY EPSTEIN". [REDACTED] did not think the woman gave her name. [REDACTED] described this woman as dark haired, young, pretty, and could not be older than 21 years old.

PAUL DeFILIPINE, from THE WALL STREET JOURNAL, contacted [REDACTED] recently. He told her he was trying to investigate [REDACTED]. He left her a message that he needed to talk to her and that he got her number from EPSTEIN's black book. The only connection [REDACTED] had to [REDACTED] was when she was a senior and had to do a project and a woman at [REDACTED] choreographed it. He sent her photos of girls to see if she recognized any of them. A photo of [REDACTED] [REDACTED] looked like the girl that recruited [REDACTED] from [REDACTED]. [REDACTED] did not recall the girl who recruited her giving her name because she took [REDACTED] information.
