[REDACTED], hereto referred to as [REDACTED], was interviewed pursuant to a proffer agreement at [REDACTED]. After being advised of the identities of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] met [REDACTED], hereto referred to as [REDACTED], through [REDACTED]. [REDACTED] thought [REDACTED] was a little older than [REDACTED]. [REDACTED] thought [REDACTED] took [REDACTED] to massage EPSTEIN. [REDACTED] was unsure if she went with [REDACTED] and [REDACTED] to EPSTEIN's home. [REDACTED] was under 18 when she went to EPSTEIN's home. [REDACTED] stated, "I know [REDACTED] asked her." [REDACTED] was "pretty sure" that [REDACTED] went to EPSTEIN's home. Going to massage EPSTEIN was not [REDACTED] "MO" because [REDACTED] "gets creeped out."

[REDACTED] met [REDACTED], hereto referred to as [REDACTED], through [REDACTED]. [REDACTED] took [REDACTED] to massage EPSTEIN and went upstairs with her the first time because [REDACTED] felt uncomfortable. [REDACTED] went approximately one to two times because she was "not into that." [REDACTED] did not recall how old [REDACTED] was when she went to EPSTEIN's home and did not recall if [REDACTED] had said anything to her about her experience.

[REDACTED] met [REDACTED], hereto referred to as [REDACTED], through either [REDACTED] or in a club. [REDACTED] was [REDACTED] friend. [REDACTED] did not recall if she or [REDACTED] brought [REDACTED] to massage EPSTEIN. [REDACTED] did not go upstairs with [REDACTED] but [REDACTED] was in EPSTEIN's home when [REDACTED] was there. [REDACTED] is a year younger than [REDACTED]. [REDACTED] saw [REDACTED] last year at [REDACTED].

[REDACTED] met [REDACTED], hereto referred to as [REDACTED], through [REDACTED]. [REDACTED] and [REDACTED] were friends and [REDACTED] introduced [REDACTED] to [REDACTED]. [REDACTED] thought that [REDACTED] was the one who brought [REDACTED] to massage EPSTEIN, but could not completely recall if it was [REDACTED] or [REDACTED]. [REDACTED] and [REDACTED] would speak about girls going to massage EPSTEIN and they talked about [REDACTED] going. [REDACTED] was dark skinned and EPSTEIN did not like her. [REDACTED] massaged EPSTEIN one time. [REDACTED] kept things to herself.

[REDACTED] met [REDACTED], whose last name she thought could have been [REDACTED] but was unsure, through [REDACTED]. [REDACTED] recalled [REDACTED]. [REDACTED] thought that [REDACTED] may have introduced [REDACTED] to [REDACTED]. [REDACTED] massaged EPSTEIN approximately one to two times. [REDACTED] described [REDACTED] as "big on top" and EPSTEIN was not into that. [REDACTED] was maybe one year older than [REDACTED]. [REDACTED].

[REDACTED] was unsure if [REDACTED], massaged EPSTEIN. [REDACTED] thought that [REDACTED] may have been over 18 years old.

[REDACTED] thought she may have asked [REDACTED], to massage EPSTEIN but was not completely sure. [REDACTED] thought that [REDACTED] may have been over 18 years old.

[REDACTED] met [REDACTED], hereto referred to as [REDACTED], through [REDACTED]. [REDACTED] took [REDACTED] to massage EPSTEIN a couple times. [REDACTED] did not complain about going. [REDACTED] did not think [REDACTED] was uncomfortable based on [REDACTED]. [REDACTED] was under 18 years old when she massaged EPSTEIN and did not go to school during that time.

[REDACTED] thought [REDACTED] last name may have been [REDACTED], but she was unsure. [REDACTED] was "big on top" as well and EPSTEIN did not like that.

[REDACTED] met [REDACTED], hereto referred to as [REDACTED], through [REDACTED]. [REDACTED] described [REDACTED] as slim. [REDACTED] took [REDACTED] to EPSTEIN's home and [REDACTED] massaged EPSTEIN approximately three to four times. [REDACTED] [REDACTED] was not going to school at the time. [REDACTED]

[REDACTED] and [REDACTED], hereto referred to as [REDACTED], [REDACTED] [REDACTED]. [REDACTED] is approximately the same age as [REDACTED]. [REDACTED] described [REDACTED] as [REDACTED]. [REDACTED] recalled taking [REDACTED] to EPSTEIN's home, but did not remember everything about it. PAPAPADAKIS recalled that [REDACTED] went upstairs while [REDACTED] waited downstairs. PAPAPADAKIS did not remember [REDACTED] talking to [REDACTED] about what happened. [REDACTED] did not think going to massage EPSTEIN was [REDACTED] "MO". [REDACTED] thought that [REDACTED] wanted money at the time. [REDACTED] stated [REDACTED].

[REDACTED] recalled bringing [REDACTED] one time. [REDACTED] [REDACTED]. [REDACTED] did not recall [REDACTED] reaction.

[REDACTED] brought [REDACTED]. [REDACTED] recalled that [REDACTED] may have gone approximately one to three times. [REDACTED]

[REDACTED] recalled [REDACTED] massaging EPSTEIN. [REDACTED] thought that [REDACTED] may have brought [REDACTED]; [REDACTED] was unsure if she was present when [REDACTED] massaged EPSTEIN. [REDACTED]. [REDACTED] recalled [REDACTED] telling her about [REDACTED] going to EPSTEIN's residence.

[REDACTED] recalled [REDACTED] also massaged EPSTEIN. [REDACTED] recalled that there were more girls that massaged EPSTEIN but she does not remember

their names.

[REDACTED] met [REDACTED] when she was walking her dog and they started chatting and became friends. [REDACTED]

[REDACTED] would tell the girls she brought that when they massaged EPSTEIN they would see EPSTEIN come into the room and he would usually be on the phone. EPSTEIN would take off his robe, and sometimes he would tell the girl what cream to use or he would have it ready. Sometimes EPSTEIN would ask a girl her name and age. When EPSTEIN turns around, he is going to touch himself and want his nipples touched. [REDACTED] would not tell the girls that EPSTEIN would use a vibrator on a girl because he did not do that at first.

If [REDACTED] did not have new girls, [REDACTED] would ask about girls she had already brought and EPSTEIN would tell her yes or no in regards to them coming back. EPSTEIN did not like thick girls, big chested girls, and dark skinned girls. [REDACTED] thought that the girls that she had brought cut her off at some point. [REDACTED] thought that the girls she brought may have possibly brought other girls because EPSTEIN stopped asking for girls she had already brought and kept asking for new girls.

[REDACTED] stated that [REDACTED] did not feel comfortable so [REDACTED] felt that was why [REDACTED] wanted [REDACTED] to go with her to EPSTEIN's home.

[REDACTED]. [REDACTED], [REDACTED] and [REDACTED] talked about EPSTEIN but did not talk with other girls about their experiences. [REDACTED] did not know why he kept she and [REDACTED] around. [REDACTED]

When EPSTEIN paid a girl [REDACTED] had brought, he sometimes told the girl to give [REDACTED] half of the money. [REDACTED] did not see LESLIE at EPSTEIN's home. [REDACTED] had gone to LESLIE's office to pick up money on

approximately two occasions. [REDACTED] thought that she may have asked EPSTEIN for money and he had told her to see [REDACTED] about receiving the money. [REDACTED] did not go upstairs into the office but rather [REDACTED] came down and gave [REDACTED] money in an envelope.

[REDACTED] described EPSTEIN as testing things out to see how far it would get but he was not forceful. [REDACTED], [REDACTED], and [REDACTED] would talk about their experiences. [REDACTED] and [REDACTED] talked about the vibrator EPSTEIN used because they were "weirded out" by it. [REDACTED] described [REDACTED] as being more selfish and more interested in getting her own girls.

[REDACTED] was asked if she recalled bringing someone named [REDACTED]. [REDACTED] stated she had a friend [REDACTED] who [REDACTED]. [REDACTED] did not recall [REDACTED] massaging EPSTEIN.

[REDACTED] was asked if she recalled bringing someone named [REDACTED]. [REDACTED] stated [REDACTED] was [REDACTED]. [REDACTED] stated she did not recall taking [REDACTED] to massage EPSTEIN.

[REDACTED] stated that it was [REDACTED] thing to go out to the clubs and meet people. [REDACTED] would take time after meeting someone before she mentioned EPSTEIN. EPSTEIN never told her to be secretive about it.

[REDACTED] recalled being in the room when EPSTEIN asked for the girls' ages and asked to see their ID's. EPSTEIN told [REDACTED] to make sure a girl brought her ID. [REDACTED] recalled being in the room when EPSTEIN asked to see one of the girl's ID; the girl was under 18. The ID's the girls brought were either school ID's or a driver's permit. The school ID's had their date of birth and grade on it. [REDACTED] stated that when she spoke with EPSTEIN on the phone he never said goodbye, but rather just hung up the phone.
