FEDERAL BUREAU OF INVESTIGATION

██████████ was interviewed in Orlando, Florida regarding a federal investigation involving the sexual exploitation of minors. After being advised of the identity of the interviewing agents and the nature of the interview, ██████████ provided the following information:

In the Spring of 2004, ██████████ Junior year attending ██████████, ██████████ approached ██████████ about providing a massage to a guy in Palm Beach. ██████████ identified that guy as JEFFREY EPSTEIN. ██████████ said the guy was looking for girls to give him massages. ██████████ stated that ██████████ could make \$200.00 for providing the massage. ██████████ also told ██████████ that she just needed to dress and look cute. ██████████ advised ██████████ that EPSTEIN might try to touch her but that if she felt uncomfortable she could tell him to stop or she could leave. ██████████ told ██████████ that if EPSTEIN asked her age she should say she was eighteen. EPSTEIN never asked ██████████ her age.

██████████ drove ██████████ to EPSTEIN's residence the first time ██████████ provided EPSTEIN a massage. ██████████ was sitting in the kitchen when EPSTEIN's Assistant, ██████████ Last Name Unknown (identified as ██████████) came in and took ██████████ upstairs. ██████████ showed her how to setup for the massage. ██████████ left and ██████████ waited alone in the room for EPSTEIN.

EPSTEIN entered the room wearing a towel. He laid on his stomach on the massage table. ██████████ had told ██████████ to massage EPSTEIN's calves and feet. EPSTEIN was really nice. He asked her about college and what she wanted to do for a career. EPSTEIN asked her to massage his shoulders and later when he turned over he asked her to massage his chest. EPSTEIN told her repeatedly that she did not have to be shy. EPSTEIN asked her to take off her clothes, but she did not. As ██████████ massaged EPSTEIN, he grabbed ██████████. ██████████ got really nervous when he ██████████. EPSTEIN would make comments on how pretty ██████████ was and how shy she was. When he would stop pulling her close she would always back away. The massage ended when EPSTEIN said "that was enough for today." ██████████ was unsure if EPSTEIN ██████████. ██████████ was paid \$200.00 for the massage. After the massage, EPSTEIN told ██████████ that she could also make money if she brought any of her

pretty friends to provide him with a massage. EPSTEIN said that [REDACTED] would get [REDACTED] telephone number prior to [REDACTED] leaving the residence. [REDACTED] said that EPSTEIN told her before she left that she could make more money if she would do more.

[REDACTED] believed that [REDACTED] was the one that paid [REDACTED] for bringing [REDACTED] to perform the massage on EPSTEIN. [REDACTED] did not know exactly how much money [REDACTED] was paid.

[REDACTED] got her DL her Junior year. She rode with [REDACTED] and someone else possibly [REDACTED]. [REDACTED] and [REDACTED] were her friends at the time. She is uncertain of who went first she or [REDACTED]. [REDACTED] brought [REDACTED]. [REDACTED] would sit in the kitchen. Spanish looking cook with dark hair. [REDACTED] would call and ask if she would give [REDACTED] a ride to get her to work. [REDACTED] dad would take her cellphone from her, so sometimes [REDACTED] was difficult to reach.

[REDACTED] believed she stayed in the kitchen on the 2nd visit. Went with [REDACTED] once and stayed in the kitchen while cook made food.

Third or fourth massage was much more sexual massage. EPSTEIN was in his towel asked her to take her clothes off. EPSTEIN asked her to take her shirt off and she did. He told her that she did not have to be shy. EPSTEIN appeared to [REDACTED]. EPSTEIN told [REDACTED] that she was pretty and that she had a nice body. EPSTEIN was looking at [REDACTED]. He told her to take off [REDACTED] and she did not.

[REDACTED]. She was paid \$200.00. He indicated he wanted to see her again. He knew she was a friend of [REDACTED]. She was upset by the stories she heard of what other girls were doing during their massages with EPSTEIN.

[REDACTED] took [REDACTED] on multiple times because she did not have a car or was having trouble with her vehicle.

[REDACTED] told [REDACTED] about a girl who got completely naked and they had a discussion about a [REDACTED] being used during the massages.

He was referring to his request for her to remove her clothing. His tone was frustrated or irritated. This was the first time he had been like that. She did take off her clothes but left _____ and _____ on. He _____ during the massage. He reached for _____

_____ He asked her why she was so shy. She looked away during the massage, EPSTEIN knew she was upset.

Last time she went he kept expecting.

She was disgusted with the stories she had heard about her friends.

She went to EPSTEIN's approximately ten times but only gave EPSTEIN a massage 3-4 times. _____ would call and ask her to work and she also asked about _____. _____ made excuses to _____ about why she could not work, School etc.

_____ never shed tears in front of EPSTEIN, but she believed EPSTEIN knew she was upset because of her behavior and actions. _____ would pull away from him and not look at him. He would _____. He continued to give her compliments.

He asked "Do you have sex with your boyfriend". _____ told him she was still a virgin. He said "you don't like sex"?

He asked if she liked to travel. He mentioned a friend that had a cruise ship.

_____ told _____ that EPSTEIN had offered to fly her to NY or the island. On _____ birthday, _____ believed EPSTEIN sent _____

flowers and bought her something from VS. He also got her a car. [REDACTED] told [REDACTED] that [REDACTED] had received some kind of sex toy from EPSTEIN.

EPSTEIN offered a trip to [REDACTED] and [REDACTED] for their birthdays. [REDACTED] believed the destination may have been NY but could have been the island. She is pretty sure EPSTEIN knew [REDACTED] wasn't 18.

[REDACTED] told EPSTEIN she was a junior at [REDACTED]. She believed it was the second time she gave EPSTEIN a massage.

[REDACTED] called her the second or third time to arrange an appointment for [REDACTED] to give EPSTEIN a massage. [REDACTED] called her all the other times.

[REDACTED] gave [REDACTED] rides to EPSTEIN's residence.

The last visit was when EPSTEIN's displayed the most aggressive behavior.

While waiting one time when [REDACTED] performed a massage for EPSTEIN, [REDACTED] stated that she had not seen [REDACTED] in awhile, and inquired if she wanted to work.

[REDACTED] and [REDACTED] are the same age.

[REDACTED] believed EPSTEIN gave something to [REDACTED] for her birthday. [REDACTED] believed it was on her 17th birthday but also felt [REDACTED] may have received something for her 18th birthday as well. The trip was discussed during [REDACTED] senior year which would have been when [REDACTED] was turning 18.

[REDACTED] believed [REDACTED] told her about the [REDACTED] prior to the Spring 2005 but she could not be sure.

[REDACTED] believed that EPSTEIN knew how old [REDACTED] was because they were so close and they talked a lot on the phone.

EPSTEIN knew that [REDACTED] and [REDACTED] were in the same grade.

[REDACTED] would say, "We're coming into town, can you work." The third time, [REDACTED] called regarding [REDACTED] working for EPSTEIN. [REDACTED] believed they were possibly already in town.
