[REDACTED], was interviewed at the [REDACTED] a. Present for the interview were AUSA [REDACTED] AUSA [REDACTED], Task Force Officer [REDACTED], and Special Agent [REDACTED]. After being advised of the identity of the interviewing Agents and the nature of the interview, RADABAUGH provided the following information:

[REDACTED] was arrested and that's when [REDACTED] believed that [REDACTED] put her name out there as someone who had gone to EPSTEIN's residence.

[REDACTED] grew up with [REDACTED] doing gymnastics together. When they were in high school, they were in different social circles. [REDACTED] had called to ask [REDACTED] if she wanted to make \$200. When [REDACTED] asked more about it, [REDACTED] had stated that she met a guy who was lonely, harmless, and likes massages. [REDACTED] took [REDACTED] to EPSTEIN's residence, where an "older lady" was there, which [REDACTED] later learned was [REDACTED]. There was a chef who asked her if she wanted food. [REDACTED] then asked [REDACTED] if she was ready to go upstairs. [REDACTED] stated that they walked up a staircase, which she described to be "not a normal staircase." [REDACTED] set up the massage table, then left the room. [REDACTED] did not say much to [REDACTED]. JEFFREY EPSTEIN came out in a towel and laid down. [REDACTED] felt uncomfortable. EPSTEIN was on the phone and asked her to massage his back. EPSTEIN asked her, "Do you know what I do?" EPSTEIN told [REDACTED] that he invented a liposuction machine. EPSTEIN then flipped over and put his hands under the towel. When EPSTEIN touched [REDACTED]'s buttocks, she slapped his hand away and told him, "Don't touch me again." A few minutes later, EPSTEIN attempted to touch her buttocks again. When she pushed his hand away again, EPSTEIN then jumped up, said "You're done," grabbed the money from the drawer, and threw it on the table.

[REDACTED] confronted [REDACTED] and [REDACTED] told her that EPSTEIN had not done anything like that before to her. [REDACTED] was very upset that [REDACTED] had put her in that position. [REDACTED] believed that [REDACTED] had been going to EPSTEIN's regularly. [REDACTED] stated that this occurred when she was approximately 17 years old as she would have been a junior or senior in high school.

[REDACTED] stated that [REDACTED] and [REDACTED] were friends. The three of them were having a conversation and [REDACTED] told them that EPSTEIN was a pervert. They both told [REDACTED], "yea but he pays us and pays us more to bring girls."

[REDACTED] talked about a time where she was in a hotel room with [REDACTED] and [REDACTED] received a call from [REDACTED]. [REDACTED] was then trying to call girls to get them to massage EPSTEIN. [REDACTED] told [REDACTED] that EPSTEIN would get mad at her if she "brought girls that did not want to do more." [REDACTED] asked [REDACTED] if she knew other girls who would go to EPSTEIN's residence. [REDACTED] told [REDACTED] that EPSTEIN wanted "young girls" who "knew what's up." [REDACTED] later told [REDACTED] that [REDACTED] had taken the "girl who whistle blew."

[REDACTED] described [REDACTED] as [REDACTED]. [REDACTED] learned of [REDACTED] name through [REDACTED] and from "putting things together." [REDACTED] saw [REDACTED]s picture in the news and stated that she was the same woman who had taken her upstairs.

[REDACTED] was friends with [REDACTED]. According to [REDACTED], EPSTEIN took a particular liking to [REDACTED], who was 16 years old at the time. [REDACTED] had told [REDACTED] that EPSTEIN gave her gifts, including a car. [REDACTED] stated that [REDACTED] was good friends with [REDACTED] and the two of them went to EPSTEIN's together a few times.

[REDACTED] was good friends with [REDACTED] stated something similar happened to [REDACTED] and [REDACTED] went to the police.

[REDACTED] knew that attorneys had reached out to [REDACTED] to advise her that as part of EPSTEIN's deal, he had to compensate his victims. [REDACTED] was contacted by attorneys as she was recognized as one of EPSTEIN's victims.

[REDACTED] is still friends with [REDACTED] and talks sometimes with [REDACTED]. [REDACTED] is Facebook friends with [REDACTED] and [REDACTED] and follows [REDACTED] on Instagram.

[REDACTED] had heard from [REDACTED] that EPSTEIN's investigators were harassing them, stating that the investigators reached out to family members and tried to intimidate them. The investigators would tell them, "Oh does your new boyfriend know your past...does he know you're a whore."

[REDACTED] stated that she is scared of EPSTEIN. [REDACTED] stated, "He's very powerful and he has a lot of money."
