In middle school, [REDACTED] was friends with two girls named [REDACTED] and [REDACTED]. [REDACTED] was friends with [REDACTED] (now [REDACTED]). They had all gone to JEFFREY EPSTEIN's home. They called him "Jeff". [REDACTED] was approximately 16 years old when she went to EPSTEIN's home; she had [REDACTED] remembered that it was warm out and she was wearing jeans that had been cut into capris.

[REDACTED] lived on [REDACTED] [REDACTED] met [REDACTED] there and walked to EPSTEIN's home. [REDACTED] was closest with [REDACTED]. They gave massages in underwear and got a considerable amount of money. [REDACTED]

[REDACTED] was told by [REDACTED] that she and [REDACTED] tried to recruit from [REDACTED] because the Catholic school girl was a turn on for EPSTEIN.

During this time, [REDACTED] was approximately 17 years old; the same age as [REDACTED]. [REDACTED] was approximately 17 years old. [REDACTED] was younger at 16 years old.

[REDACTED] only went to EPSTEIN's home one time. [REDACTED] mother would not allow her to have a cell phone at the time. [REDACTED] met [REDACTED] at [REDACTED] and they walked to EPSTEIN's house because it was within short walking distance.

When they arrived, what appeared to [REDACTED] as a secretary answered the door. [REDACTED] described this individual as Caucasian, with glasses, maybe a brunette in her 40's or 50's. This secretary said that Mr. EPSTEIN was waiting for them. [REDACTED] stated that the massage parlor was to the right after walking in. EPSTEIN was already undressed with a towel covering him. [REDACTED] watched [REDACTED] to follow her lead. [REDACTED] really did not like the idea but was thinking that she was ok with what was going on because of the desperate situation that she was in. [REDACTED] was standing and [REDACTED] started massaging. Before she had started massaging, they had taken off their bras. EPSTEIN told [REDACTED] to straddle him. [REDACTED] thought this happened to massage lotion on his abdomen. [REDACTED] massaged EPSTEIN with white cream lotion. EPSTEIN grabbed [REDACTED] hips. [REDACTED] had white underwear on. EPSTEIN moved his hips so that [REDACTED] vagina was rubbing his penis. EPSTEIN used his fingers to stimulate and lubricate [REDACTED]. [REDACTED] was in a thong; EPSTEIN fondled her and her panties. EPSTEIN told [REDACTED] to lean back and start fondling his testicles. EPSTEIN told [REDACTED] to fondle his testicles. EPSTEIN said, "Show her [REDACTED]; you know how I like it." This was the first time that [REDACTED] learned that fondling a man's testicles was sexually pleasurable to a man. EPSTEIN was close to ejaculating. EPSTEIN pushed [REDACTED] further down and he ejaculated on his stomach. EPSTEIN said thank you and left the room. [REDACTED] and [REDACTED] dressed. The secretary gave each of them a white envelope with money. [REDACTED] could not remember if it had \$250 or \$300 in it.

[REDACTED] understanding was that EPSTEIN only communicated with [REDACTED]. Leaving EPSTEIN's home, [REDACTED] felt very dirty and ashamed.

[REDACTED] had used her house phone number [REDACTED] to communicate with [REDACTED] and [REDACTED].

[REDACTED] thought that [REDACTED] became friends with [REDACTED]. [REDACTED] thought that [REDACTED] went to [REDACTED], [REDACTED], and [REDACTED] all talked about going to EPSTEIN's home. They told her about massaging him.

[REDACTED] remembered being pissed off at [REDACTED] when she went back to [REDACTED] home after massaging EPSTEIN. [REDACTED] had friends from high school over. [REDACTED] told [REDACTED], "Oh your butt looks great in pants.". [REDACTED] felt that made it so much worse.

[REDACTED] walked back with [REDACTED] to [REDACTED] house. When [REDACTED] saw [REDACTED] friends there, [REDACTED] did not go further into it. The friends at [REDACTED] house were [REDACTED] whose last name [REDACTED] did not recall, and [REDACTED] had the sense that they knew where she had just come from. [REDACTED] described [REDACTED] as being Dominican and [REDACTED] as being Vietnamese. [REDACTED] did not know if [REDACTED] had approached both [REDACTED] and [REDACTED]. [REDACTED] thought that EPSTEIN only liked Caucasian girls because of herself and [REDACTED] going.

[REDACTED] knew EPSTEIN as "Jeff". [REDACTED] described EPSTEIN as "loaded" and he liked to massage [REDACTED] girls. [REDACTED] recognized the wooden door as his on 71st Street. [REDACTED] thought there maybe was a white marble floor inside. [REDACTED] recalled the leather of the massage table sticking to her skin. [REDACTED] massaged EPSTEIN on the ground floor of his house; she did not go anywhere else. [REDACTED] thought in the beginning that EPSTEIN tried to make her comfortable. He said, "Hi, I'm Jeff.". [REDACTED] did not recall EPSTEIN asking her questions.

[REDACTED] described herself as the "underdeveloped" one of the group. [REDACTED] did not have big breasts. [REDACTED] felt that she did not look as sexually appealing as the other girls. EPSTEIN preferred [REDACTED]. [REDACTED] knew that [REDACTED] had gone a few times; [REDACTED] had told her that she had been there.
