After being advised of the identity of the interviewing Agent and the nature of the interview, ██████████ provided the following information:

██████████ was born and raised in West Palm Beach, Florida. ██████████ graduated from high school in Florida and has started to go back to school for dog grooming. ██████████ works in the veterinarian field.

██████████ met ██████████ ██████████, who she knew as "██████████". They both went to ██████████. New students were paired up with another student, so ██████████ was paired up with ██████████. In approximately 1999, when ██████████ was in ninth grade, she met ██████████, who she thought was a year older than her because they did not have the same classes.

██████████ and ██████████ did everything together. ██████████ and ██████████ were shopping and when they left the mall, they were in the car with ██████████' boyfriend when ██████████ said she needed to make money. ██████████ thought ██████████' boyfriend's name was ██████████ or ██████████ and he drove a ██████████ car. ██████████ told ██████████ to come with her to make money. ██████████ took ██████████ to JEFFREY EPSTEIN's home. They went in the house through the kitchen and a brown/black dog jumped and scratched ██████████ leg. The maid grabbed the dog. ██████████ and ██████████ then went upstairs through the bedroom into the bathroom where there was a massage table. EPSTEIN came into the robe in a robe, took it off, and laid down on the table. EPSTEIN unbuttoned ██████████ pants and "fingered" her. EPSTEIN turned over and wanted them to "go down" on him. EPSTEIN masturbated. EPSTEIN wanted ██████████ to shower with him. It was a sauna. ██████████ did not want to shower with him. While he was in the shower, ██████████ and ██████████ cleaned up the room and washed the lotion off of their hands. When ██████████ and ██████████ were in the car leaving,

[REDACTED] handing [REDACTED] \$300.

[REDACTED] recalled she was in tenth grade when she went to EPSTEIN's home because she remembered that she had just gotten her license at 16 years old.

[REDACTED] went to EPSTEIN's home at least nine times, but not more than fifteen times. [REDACTED] has since found pictures of the time where she first received money from going to EPSTEIN's and had bought a blue vest. During that time, she met her children's father around December 2001 when she was in eleventh grade.

[REDACTED] would call [REDACTED] or show up at her home in [REDACTED] and say, "Let's go for a ride". EPSTEIN always masturbated and fingered [REDACTED]. [REDACTED] gave [REDACTED] the money each time, which was about \$300 each time they went. [REDACTED] always went with [REDACTED] to EPSTEIN's home and [REDACTED] was always in the room with [REDACTED] and EPSTEIN. [REDACTED] did not know anything before she went the first time. When [REDACTED] saw the massage table, she "figured it out".

EPSTEIN asked [REDACTED] and [REDACTED] how old they were. [REDACTED] looked at [REDACTED] and [REDACTED] told EPSTEIN that they were 18 years old.

EPSTEIN invited [REDACTED] on a trip to Thailand to be a model. EPSTEIN told her had friends in the modeling industry and could get her a job. EPSTEIN was going to fly [REDACTED] on his private plane. [REDACTED] did not have a passport and EPSTEIN told her not to worry about it. [REDACTED] did not tell anyone about it, not even [REDACTED]. A car company called [REDACTED] house to pick her up for the trip. [REDACTED] had packed a bag and went to the airport. [REDACTED] then backed out and called her friend [REDACTED] to pick her up at the airport.

[REDACTED] recalled a time where she was on the back balcony with EPSTEIN talking before they went inside. There were pictures [REDACTED] took of [REDACTED] and [REDACTED] in EPSTEIN's house. [REDACTED] did not let EPSTEIN take pictures of her.

[REDACTED] never met anyone else at EPSTEIN's home.
