[redacted], DOB [redacted], email address [redacted], was interviewed at [redacted]. Present for the interview were AUSA [redacted], AUSA [redacted], FBI Victim Specialist [redacted] Detective [redacted] and Special Agent [redacted]. After being advised of the identities of the above listed individuals and the nature of the interview, [redacted] provided the following information:

[redacted] has known EPSTEIN for many years and believes he is a little scary. [redacted] was born and raised in [redacted]. She went to both elementary school and high school in [redacted]. For pre-K through 8th grade she attended [redacted] which is a private Catholic school. She then attended [redacted] she then attended [redacted] eventually received her GED.

[redacted] recalled being approximately 14 years old when she was hanging out with her friends in front of [redacted] near [redacted]. Another girl, approximately 17 years old, approached the group of them and asked if they would like to hang out and smoke weed. This girl lived on her own in her own place. [redacted] ended up becoming friends with this girl and is still friends with her to this day. This girl told [redacted] about a rich guy that they should meet with. [redacted] agreed to go. Her friend did her make up and picked out her lingerie. [redacted] felt as though she was just following her friends path. They traveled together to around 71-72 Street and Madison. She recalled the home having huge doors. They went inside and [redacted] saw pictures of EPSTEIN and CLINTON everywhere. EPSTEIN came down the stairs to greet them and said, "Hey.. [redacted]..you know what to do". They then went to the elevator, and got out to walk into a massage room. [redacted] recalled naked pictures of girls being on the walls. At the time, [redacted] was wearing a bra and panties (lingerie) and cut off shorts. After EPSTEIN entered, [redacted] and her friend started massaging his feet using a cream or oil. They moved to massage his calves and then up further. EPSTEIN had casual conversation with them at this time; small talk to make them feel comfortable. [redacted] believed that a small part of EPSTEIN actually cared about the massage portion of the massage. He said things like, "Oh yeah, right there" and "feel that knot?" as they were massaging him. EPSTEIN then turned over, and they started pinching his nipples, and EPSTEIN began to masturbate. EPSTEIN

told [REDACTED] to get on the table so she did. He started using a back massager on [REDACTED] (which he did a lot). When they were done, [REDACTED] was paid \$300 from [REDACTED] while still inside of the massage room. EPSTEIN had handed the money to [REDACTED] in \$100 bills.

After this occasion, EPSTEIN called [REDACTED] often to request [REDACTED] to come back. [REDACTED] told [REDACTED] that he wanted to see her again.

Another girl, that [REDACTED] knew of that went to EPSTEIN's house, was [REDACTED] (a [REDACTED] girl). [REDACTED] described her as one of her friends and was somewhat of a dropout around that time.

[REDACTED] knew [REDACTED] was 17 so that is how she knew she was 14 because she knows she is 3 years younger than her.

After the first incident at EPSTEIN's house, [REDACTED] began going there often, approximately two times a week. She went with [REDACTED] a lot but she would wait outside. [REDACTED] was no longer nervous going there. [REDACTED] phone number was given to EPSTEIN and begins [REDACTED] then began receiving calls to schedule her to come massage. This went on for about a month then [REDACTED] started to bring other people in. There was an overlap in time where [REDACTED] would both massage him and bring people. [REDACTED] made it a point to try and bring EPSTEIN more girls. Either EPSTEIN asked or she offered. EPSTEIN offered \$300 to recruit a girl, and the girl she brought would also receive \$300. [REDACTED] would then bring an average of 3-4 people a week.

[REDACTED] explained to the girls that they would get \$300 to give a massage with no sex involved. If they were comfortable during the massage, [REDACTED] would leave the room. EPSTEIN set the time for the massages, and [REDACTED] helped to arrange the massages. [REDACTED] told the girls that they must be on time. LESLIE would pick up the phone if [REDACTED] called EPSTEIN; and LESLIE then transferred the call to EPSTEIN. [REDACTED] recruited new people through friends of friends at parties and tanning salons. [REDACTED] told the girls she brought to bring their friends. [REDACTED] felt as though this was a business.

[REDACTED] lied to her parents. [REDACTED] lied to [REDACTED] about how much she was going.

[REDACTED] told EPSTEIN, "I have another person, do you want to meet them?". EPSTEIN said things like "no black girls" and "so what do we have". [REDACTED] went down the roster of girls with him. [REDACTED] understanding of what he wanted was really pretty girls. EPSTEIN once rejected an overweight girl that [REDACTED] brought. [REDACTED] felt as though she was in a relationship with EPSTEIN, as if they were doing this together. The girls [REDACTED] brought were all young...about 15, 16, 17 years old. She knew this because they were primarily her age. Even as

EPSTEIN was getting in trouble [REDACTED] was still bringing in girls. During that time, he began checking their ID's.

When [REDACTED] was 17 years old she spent about 7 months in [REDACTED]. When she came back, she went back with EPSTEIN. [REDACTED] was not sure if she ever talked with EPSTEIN about her or other girls' ages. [REDACTED] believed it was a clear understanding that he liked young girls. [REDACTED] recalled EPSTEIN telling her that a 22-23 year old girl was too old. EPSTEIN may have asked about girls ages, hair, height and race. [REDACTED] might have told him girls' ages.

During the times [REDACTED] massaged EPSTEIN, he used massagers on her. She would pinch his nipples and he would masturbate. At one point, another girl would join in the room. EPSTEIN would say, "She's going to hang out with us today". [REDACTED] described this girl as a cute blonde, slightly more developed, and about [REDACTED] height. [REDACTED] did not know her name. While inside the room, EPSTEIN made this girl "go down" on [REDACTED] while she was standing up. Then, the girl left and EPSTEIN and [REDACTED] would "finish". On one occasion, this girl and [REDACTED] showered with EPSTEIN. [REDACTED] stated that it wasn't all just a massage as there was one time where EPSTEIN "had sex" with [REDACTED].

When other girls were involved, EPSTEIN would typically get massaged, they would pinch his nipples, and EPSTEIN used a massager on them, then he would masturbate.

On one occasion, [REDACTED] was brought to a white room. A different time, [REDACTED] was brought to a huge dining room. On one occasion, when [REDACTED] brought in another girl, she met Naomi Campbell. [REDACTED] believed EPSTEIN was a multi-billionaire that knew everyone and was one of the most powerful men in the world. EPSTEIN made [REDACTED] feel cool but she knew she needed to "lock it down". During one of the massages, EPSTEIN was on the phone with DONALD TRUMP. One of [REDACTED] friends met CHRIS TUCKER at his house. [REDACTED] thought that he may have either worked for Victoria's Secret or was a scientist. [REDACTED] and EPSTEIN did not talk much about [REDACTED] life. [REDACTED] once asked him for help in finding a dermatologist which he never did help her. EPSTEIN asked [REDACTED] if she would like an I-Pad for Christmas, then never gave one to her. EPSTEIN never gave [REDACTED] gifts and [REDACTED] never asked for anything from him. [REDACTED] just did what he said. She recalled that one girl had her entire apartment furnished by EPSTEIN and another was sent to a dentist by him.

[REDACTED] recalled that when she came back from [REDACTED] EPSTEIN told her, "You really grew up; I watched you grow up from a young lady".

[REDACTED] had told her brother about the EPSTEIN situation at the time that it all happened. She would brag but at the same time lie about the situation saying she never actually did anything with EPSTEIN. [REDACTED] said only her friends would do things. At some point, her brother showed her a newspaper that showed EPSTEIN was in trouble. EPSTEIN was still seeing people even after he got in trouble.

There was a fair amount of time that [REDACTED] was bringing people to him that were under the age of 18. When she came back from [REDACTED] [REDACTED] was 17 turning 18 and recalled bringing girls that were around her age. The girls would tell [REDACTED] what happened in the room after they came out. [REDACTED] recalled two girls being kicked out by EPSTEIN, and he being very annoyed. EPSTEIN said to [REDACTED], "Are you fucking kidding me" in reference to one of the girls she brought and didn't like. He came down the stairs, and just turned around and walked back up.

[REDACTED] held resentment against her friend that initially brought her to EPSTEIN. [REDACTED] felt bad about the girls she brought but realized they were all kids and he was a grown man. [REDACTED] told her mother that she was presently speaking with law enforcement, but her mother only knows half of the truth.
