During call with AUSAs [REDACTED] [REDACTED] provided attorney proffer re topics [REDACTED] will be prepared to cover during upcoming interviews in [REDACTED]

- Met GM in [REDACTED] Sept. 1997, introduced by a friend when was 22 years old, just left university, and wanted to go to US
- Met JE & assaulted around that time in [REDACTED]
- Immediate aftermath of assault
- [REDACTED] going to NY [REDACTED] for a few years
- [REDACTED]
- Further assaults in US involving JE & GM, one in particular involving GM
- There are various assaults
- [REDACTED] traveled to PB & VI and was assaulted at both locations as well by JE
- [REDACTED] recalls details, e.g., of JE's bedroom
- Experienced grooming behavior by GM
- Other people who were around during the time, [REDACTED]
- 1998, [REDACTED] gets a boyfriend, JE somewhat backs off
- [REDACTED] met [REDACTED] in PB
- [REDACTED] goes on big trip in March 2001 where went around Europe [REDACTED] on trip, doesn't really have info on what happens in London because [REDACTED] spent weekend [REDACTED] with her family, but then came back on plane.
- [REDACTED] met President Clinton on different trip
- [REDACTED] on the plane a lot, and a lot happened on that plane
- Various offers made to [REDACTED] by GM & JE in 2001, including property and other things
- August 2001, [REDACTED] having a very difficult time with GM [REDACTED]
- [REDACTED] stays in contact because JE/GM pay her student fees, so takes trip to VI in 2003 (very unpleasant trip for her), GM becomes insistent in demands
- [REDACTED] not aware of young girls being delivered to JE because [REDACTED] was not around for that, but does have details of other people coming in from, e.g., Mar-a-lago to massage JE
- [REDACTED] goes back to collect her things later on around 2008, unpleasant again
- [REDACTED] prepared to explain when her last contact with GM/JE was [REDACTED]

- [REDACTED] is embarrassed she let this happen to herself
- [REDACTED] did not have any sense of minors being involved, and left in 2001 before took off in Palm Beach, though she did know [REDACTED] (unclear whether [REDACTED] knew [REDACTED] was under the age of 18); knew [REDACTED] was giving massage, but not clear [REDACTED] knew anything beyond that re [REDACTED].
