[REDACTED], was interviewed via Skype while agents and prosecutors were present inside of 1 St Andrews Plaza. Present for the interview was Task Force Officers, [REDACTED]. Also present via Skype was [REDACTED] Attorneys [REDACTED]. After being advised of the identity of the interviewing Agents and the nature of the interview, [REDACTED] provided the following information:

[REDACTED]

[REDACTED] meets [REDACTED] at some point during her stay in New York. [REDACTED] was working at a [REDACTED], when [REDACTED] comes in and approaches her. She asks if she would like to make money to give a massage. She says would you like to make \$400 and it takes about 45 minutes. [REDACTED] agrees to meet [REDACTED] for lunch to talk about it. [REDACTED] is described as being about [REDACTED]. This incident occurred somewhere around the summer of 2004. She is not sure what [REDACTED] last name is but believes it starts with an [REDACTED] and could be [REDACTED]. She learned her last name later after the incident from her friend [REDACTED].

About the next day they meet for lunch nearby. [REDACTED] states to [REDACTED] that she has to massage her boss. [REDACTED] states that her boss has seen [REDACTED] inside of the [REDACTED] before and says she is beautiful. At this

point she does not agree to go massage him right away but agrees to go out to a club with [REDACTED] and [REDACTED]. They eventually go dancing together where [REDACTED] convinces [REDACTED] to do it. [REDACTED] tells her she has done it before and it is easy.

A few days after this [REDACTED] directs [REDACTED] to go to the house. [REDACTED] and [REDACTED] go to the house together and [REDACTED] brings her inside. An unknown woman/maid answers the door (short, Hispanic, tan, dark hair). [REDACTED] waits in the kitchen and this woman brings [REDACTED] up in the elevator. She is brought to a massage room, and states to [REDACTED] "go ahead in" then leaves. Then EPSTEIN comes in wearing a towel. While on the massage table he directs [REDACTED] to rub his back. He then turns around and requests [REDACTED] continue on his chest. He requests she massage around his nipple area so she does. EPSTEIN then grabs her breasts and states "are you uncomfortable". He then touches [REDACTED] vagina and begins masturbating. EPSTEIN ejaculates almost immediately, gets up and says "ok".

After this the maid takes [REDACTED] back downstairs to the kitchen area to meet with [REDACTED]. While down there she observes a large dining room area with a huge table in it. She observes a giant photo on the wall. She asks if she can take a picture of the dining room to which she is told no because of legal issues. She is then offered fruit. EPSTEIN comes down dressed and hands [REDACTED] money. [REDACTED] then pays \$400 to [REDACTED] right away. [REDACTED] then takes [REDACTED] back [REDACTED]. During this trip [REDACTED] asks if she wants to massage him again to which she says no. She asks [REDACTED] if she would like to recruit other girls and that she would get \$600 a girl to do so. After this incident [REDACTED] never sees or hears from [REDACTED] or EPSTEIN again.

[REDACTED] recalls calling someone shortly after leaving EPSTEIN's house using her phone number [REDACTED]. [REDACTED] still uses that same phone number today. At the time she was giving the massage [REDACTED] did not know his name at all. [REDACTED] learned his name when she saw an article about him on facebook that contained his photo.
