[REDACTED], date of birth (DOB) [REDACTED], was interviewed at [REDACTED]. Present for the interview were [REDACTED].

After being advised of the identity of the interviewing Agents and the nature of the interview, [REDACTED] provided the following information:

[REDACTED]

When [REDACTED] was 14 years old she was introduced to JEFFREY EPSTEIN. [REDACTED] described herself as having braces at the time. [REDACTED] and [REDACTED] were at a high school party when they were approached by a girl around their age. They were told they could make \$200 if they gave a massage naked or with their bra and panties on. At first, [REDACTED] went by herself then brought [REDACTED] with her. [REDACTED] estimated that she had gone to EPSTEIN's residence approximately sixty times over a three to four year period.

The first time [REDACTED] met EPSTEIN, she told him that she was 16 because her friends told her to not tell him her actual age. [REDACTED] thought that EPSTEIN was a brain surgeon or doctor but does not recall why she thought that. [REDACTED] met [REDACTED] and [REDACTED] gave [REDACTED] her phone number. [REDACTED] thought [REDACTED] was "like a live in assistant." [REDACTED] described [REDACTED] as "very nice." [REDACTED] would sometimes take [REDACTED] upstairs and show [REDACTED] how to set everything up. [REDACTED] would call [REDACTED] before they got on a plane. [REDACTED] would tell [REDACTED] when they would land and ask [REDACTED] if she had any girls. [REDACTED] would ask questions about the girls, asking what they looked like, etc. [REDACTED] would have to express to EPSTEIN and [REDACTED] that the girls had things going on and activities that they were involved in. [REDACTED] recalled receiving a call from New York.

[REDACTED] stated that EPSTEIN was "pushy and had control of the situation." EPSTEIN would have a robe on or come in the room wearing slacks and a

shirt. EPSTEIN would lay on the table then EPSTEIN would want [REDACTED] to pinch his nipples. While [REDACTED] pinched his nipples, EPSTEIN would hold [REDACTED] EPSTEIN would touch [REDACTED] and tell her, "It's ok." EPSTEIN gave off the vibe that they were not doing anything wrong. EPSTEIN was "super casual" about it all. [REDACTED] did not go further into the details about the sexual contact at this time. [REDACTED] was always paid in cash in 100 dollar bills, sometimes by [REDACTED] and sometimes by EPSTEIN, who would place the money on the counter or take it out of the pocket of his robe.

The first time [REDACTED] massaged EPSTEIN, he asked her if she had friends that she could bring with her. [REDACTED] would get paid \$200 for each girl that she brought to EPSTEIN. EPSTEIN made her feel like his sidekick. EPSTEIN would call and "hound" [REDACTED] for girls that were underage. EPSTEIN did not say specifically that he wanted "underage girls" but told her "you know what I like." [REDACTED] knew that meant he wanted younger girls. [REDACTED] learned this through "trial and error." EPSTEIN would tell her which girls he liked. [REDACTED] was bringing girls that were from a trailer park environment. [REDACTED] brought girls who were young. [REDACTED] initially told the girls that she brought that they would just be giving a massage. Later, she told the girls that he's "gonna jack off and look at you." [REDACTED] told this to the girls so that they "wouldn't freak out" because EPSTEIN had asked her why she had not told the girls what to expect. EPSTEIN was very open with what girls he liked and did not like. EPSTEIN did not like black or mixed girls. [REDACTED] told [REDACTED] that when she took black and/or mixed girls, EPSTEIN "flipped out." [REDACTED] would relay messages about girls that EPSTEIN liked.

[REDACTED] believed that there were certain girls that EPSTEIN "took to a different level." [REDACTED] recalled taking a girl, [REDACTED], who looked very young and EPSTEIN really liked her. EPSTEIN gave \$300 to both of them. [REDACTED] was shaken up and never wanted to go back.

[REDACTED] described that when she brought girls that they would have a routine where both [REDACTED] and the other girl would go in together to massage EPSTEIN for approximately 30 minutes. Each girl would massage a side of EPSTEIN. EPSTEIN would then flip over and ask [REDACTED] to go downstairs. EPSTEIN would tell [REDACTED] that she could have whatever food she wanted while she waited. [REDACTED] recalled taking [REDACTED], who would have been 16 or 17 years old at the time. [REDACTED] stormed out and told [REDACTED], "Let's go."

When [REDACTED] was an adult and working [REDACTED] she brought a woman, who was an adult, and the woman took off her clothes, but EPSTEIN said that he had to go. EPSTEIN gave the woman money and left before any massage took place. [REDACTED] stated the adult woman that she took to EPSTEIN did not care to go back.

[REDACTED] remembered that there was an apartment at EPSTEIN's residence where those who worked for EPSTEIN stayed. [REDACTED] recalled seeing a chef who worked there. [REDACTED] stated that it was "pretty obvious" what was going on in the residence. [REDACTED] recalled seeing [REDACTED] quite a bit at EPSTEIN's residence over a two year period. [REDACTED] "seemed like his sex toy."

[REDACTED] received lotions and Victoria's Secret items from EPSTEIN. [REDACTED] knew that when [REDACTED] was pregnant, EPSTEIN bought her a golden rattle and all the remaining items off of her registry.

EPSTEIN called [REDACTED] one time, saying that he had a friend that he wanted her to meet. [REDACTED] did not go to meet him that time. [REDACTED] had less contact with EPSTEIN when she turned 18.

[REDACTED] saw EPSTEIN's mug shot on TV. [REDACTED] called his phone number and [REDACTED] answered and told her not to worry and that she would be taken care of. [REDACTED] told her that Bob Critton would be her attorney and gave WILD his information. [REDACTED] told [REDACTED] that if she did not say anything then she would be taken care of. [REDACTED] met with the attorney but there was a personality clash and [REDACTED] did not understand why she would have needed an attorney. [REDACTED] contacted a different attorney and eventually met [REDACTED]. [REDACTED] was contacted by the FBI. [REDACTED]

[REDACTED] had heard that EPSTEIN's investigators were harassing [REDACTED] by shining lights in her window. [REDACTED] had to be placed in a hotel in a different location because of it.

[REDACTED] met a woman, [REDACTED] when [REDACTED] had told her that she had gone to EPSTEIN's residence. [REDACTED] also knew that [REDACTED] and [REDACTED]'s friend [REDACTED] also went to EPSTEIN's residence. [REDACTED] recalled that [REDACTED] was another girl that went to EPSTEIN's residence and may have been the one who took [REDACTED].

[REDACTED] was contacted by the media, including the Miami Herald. [REDACTED] WILD was constantly called by journalists and had to change her phone number.

[REDACTED] stated that she was open and willing to speak further in depth at another date.
