in Sweden. In France, they get on a yacht which was guarded by security guards with guns. They were ex-Mossad agents. The first night on the yacht ROSJO tries to get [REDACTED] into his room to sleep with him.

[REDACTED] complains to VECK and he places her into a room of her own. ROSJO wanted off the boat. She talks to some of the security who give her tips on how to survive. One night they allow her to go to shore to go out to dinner. ROSJO is "edgie" and upset that [REDACTED] is not available for him. Afterwards [REDACTED] and ROSJO fly back home together. During the flight ROSJO mentions a girl disappearing. When they got to the airport no one asked them any questions.

When she is back at home ROSJO says that BILL CLINTON and TONY BLAIR are coming to town. He says "we gonna have an orgy" and "I want you to be with BILL CLINTON". [REDACTED] does not go to this orgy.

The next day ROSJO comes over and brutally rapes [REDACTED]. He says, "If you ever mention his name that she and her family [REDACTED] will be killed." ROSJO then kicks [REDACTED] out of his house and she gets fired. [REDACTED] tells the police (Scotland Yard) the next day of the incident. The police tell [REDACTED] that they tried to talk to ROSJO but cannot reach him and that he is too powerful. CAESAR offers her \$10,000 to be quiet and threatens her family. [REDACTED] accepts the \$10,000 offer.

[REDACTED] tells the [REDACTED] Secret Service. She was in fear for her life but tries to live her life normally.

[REDACTED] [REDACTED]  
[REDACTED] begins getting lots of death threats and blackmail online. She initially believed it was related to [REDACTED] or WEINSTEIN. In 2009, [REDACTED] shows some of these death threats to NYPD. She now believes that these threats are related to ROSJO. She then flies back to [REDACTED]. A man tracks her down [REDACTED], calls her and says that he is writing a book.

She then moves [REDACTED]. The police department [REDACTED] takes the case and tells her to lay low for six months. They think that the threats are coming from three unknown persons in the United States.

Her online threats begin to diminish.

STELLA PACHENIK, who is related to BLACK HUGH, gives interviews with the *Daily Mail* about WEINSTEIN pretending to be [REDACTED]. She gets sent to the U.S. and gets plastic surgery to look like [REDACTED]. She has blonde hair and calls journalists to talk about WEINSTEIN, claiming she is a victim and then taking it back.

Things got weird after [REDACTED] spoke up about WEINSTEIN. She thinks that I24 is associated with Israeli spies. She thinks that her threats from this source are related to ROSJO.

After EPSTEIN got arrested WILINDG stopped getting threats.

LISA BLOOM hired them.

[REDACTED] writes to a HUGH spokesperson on LinkedIn. This was about two months ago. Two days later her computer gets hacked. One day after that her phone gets hacked. She then gets her computer fixed. She then finds out that the Interpol guy had lied to her. She blocks him because she gave him and his brother her personal information.

[REDACTED] contacts an investigative journalist [REDACTED]. This past Saturday he opened up to [REDACTED] and she tells him that MAXWELL was arrested. [REDACTED] finds out from the journalist that ROSJO was investigated back in the 90's over financial crimes in London. CHRIS BECK is involved in suspicious money transfers.
