[REDACTED] met Epstein two times in 2002. The first time, she flew from  
[REDACTED] to New York, was picked up by a driver and taken to Epstein's  
private apartment, somewhere in Manhattan, close to Epstein personal  
residence. [REDACTED] was the only one at the apartment.

Epstein picked her up, took her to SOHO, visited some art galleries,  
Epstein bought a hat for her, had coffee together, attended the Phantom  
of the Opera presentation, along with another woman. [REDACTED] went back to  
[REDACTED] after a couple of days.

The second trip was in February 2002. She arrived at Epstein apartment in Manhattan, but this time 2 or 3 young women were already there. They all flew in Epstein private jet, including Mrs. Maxwell, down to Epstein residence in Florida.

██████ heard the people inside the jet that the Queen of England's designer was among the passengers. ██████ recalls one of the girls getting sick during the fly and taken to the local hospital.

After everyone got into the house, ██████ was ushered inside Epstein's master bedroom, where a woman she later on found out was the real estate person for Epstein, gave ██████ a massage. Epstein entered the room, grabbed a towel, slapped ██████ on her butt and said "if you want you can join the other girls in the Jacuzzi" ██████ didn't join the other girls because she thought it was very weird.

██████ and the other girls, along with Epstein and Maxwell, went to Mar-a-Lago, shake hands with President Donald Trump and his wife Melania and with Regis Philbin and his wife, as well. ██████ said there was some type of sorority celebration but the details are very fuzzy at the moment.

██████ said the group made plans to go to the Caribbean. ██████ refused to go because she was ██████. The girls seemed to have been underage and very close. ██████ didn't talk to them much, just casual conversations.

Epstein gave ██████ only cash money for whatever she wanted/ needed to buy during her visits. ██████, after living Florida, never heard from Epstein or Maxwell again.
