Details:

On 07/12/2019, at 5:17 p.m. Eastern Time, [REDACTED] [REDACTED], date of birth [REDACTED] [REDACTED], called the FBI National Threat Operations Center (NTOC) to report information pertaining to Jeffrey Epstein.

[REDACTED] provided the following information:

[REDACTED] has a friend, [REDACTED], currently residing in [REDACTED], who was [REDACTED] for Jeffrey Epstein from [REDACTED] until approximately [REDACTED] or [REDACTED] while Epstein was located in Florida. [REDACTED] claims to have been present when Epstein purchased the island, and [REDACTED]. In addition to [REDACTED] for Epstein, [REDACTED] was [REDACTED].

[REDACTED] stopped [REDACTED] for Epstein when she "figured out that all of the little girls he had around weren't his nieces." [REDACTED] told [REDACTED] [REDACTED] is one of her biggest regrets and she has not reported anything to law enforcement because she is afraid of the repercussions it would have for her and her family. Additionally, [REDACTED] was paid under the table by Epstein and she believes there is likely not a record showing she was involved with him.

[REDACTED] offered various other pieces of information to [REDACTED], including the names of some of the guests at Epstein's parties; among the guests mentioned were Bill Clinton and Donald Trump. [REDACTED] was also

friends with Epstein's wife, whom she claimed "helped to train the girls." [REDACTED] was reluctant to give [REDACTED] any more information about Epstein, other than to say she regretted [REDACTED]

[REDACTED] believes a mutual friend of hers and [REDACTED], [REDACTED], no identifiers provided, may have more information about the details of when [REDACTED] [REDACTED] for Epstein. [REDACTED] told [REDACTED] that [REDACTED] had talked to her on different occasions about Epstein.
