Details:

On 11/10/2019, at 2:43 p.m. Eastern Time, Sean Crutcher, date of birth [REDACTED], called the FBI National Threat Operations Center (NTOC), to report Robert Trivers, email address [REDACTED], a United States citizen and well known scientist who lives [REDACTED], for having personal relations with Jeffrey Epstein, and speculation of sexual assault of [REDACTED], [REDACTED], who is 15 years old.

Crutcher provided the following information:

Crutcher called the FBI from [REDACTED]. Crutcher is a follower of Trivers' scientific ideologies and described him as a "genius" who is referenced in many popular readings.

A few months ago, Crutcher emailed Trivers via his email address found on his website inquiring to meet with him to discuss science. Crutcher met Trivers on 07/14/2019 and 07/15/2019 [REDACTED].

Crutcher "knows for a fact" that Trivers was a personal friend of Epstein. Trivers allegedly told Crutcher this and sources on the Internet confirmed it.

(At this point of the telephone interview, the call was dropped from Crutcher's end.)

once again and the following additional information was obtained.

Crutcher and Trivers met at [REDACTED], a restaurant in [REDACTED]. Trivers lives [REDACTED]. While at the counter, Crutcher witnessed Trivers sexually assault [REDACTED] by "caressing her buttocks." Crutcher said, "In an American situation, it would cause a huge scene."

Crutcher and Trivers also met at [REDACTED], another restaurant [REDACTED]. Crutcher witnessed Trivers caress [REDACTED] thigh "in a very sexually suggestive manner." When asked to explain, Crutcher said that Trivers was moving his hand all around [REDACTED] thigh, moving in the direction toward her vagina.

Crutcher's also provided the above information to [REDACTED], email address [REDACTED].

The second call was also dropped due to poor connection from Crutcher's end.
