Details:

On 07/10/2019, at 1:28 p.m. Eastern Time, [REDACTED], date of birth [REDACTED]

[REDACTED], called the FBI National Threat Operations Center (NTOC) to report information on Jeffrey Epstein.

[REDACTED] provided the following information:

In September of 2002, [REDACTED] moved to [REDACTED] where she met FNU LNU, who was [REDACTED], at a coffee shop, or bar. [REDACTED] expressed to FNU LNU how expensive it was to live in [REDACTED] FNU LNU told [REDACTED] about an older family friend by the name of Jeffrey. Jeffrey was like an uncle to FNU LNU and would help young girls trying to make it in NY by paying them for private lessons, like massages, painting lessons, and dancing. FNU LNU informed [REDACTED] not to provide her age to Jeffrey because he like to help younger girls.

[REDACTED] asked FNU LNU if there would be sex involved, and she was informed it was strictly platonic.

FNU LNU gave [REDACTED] the address, close to 5th Avenue of Madison area, between two main streets- like 5th -6th or 6th -7th in downtown Manhattan, NY. It was a mansion in a fancy residential area.

When [REDACTED] arrived at the mansion, a butler answered the door and led her to the elevator where she was taken to the 3rd floor. When she got off the elevator she saw a bedroom at the end of the hall, a bathroom, and a massage room. She was led to the massage room where she waited for about 45 minutes. She believes there were cameras in the room watching her.

Jeffrey Epstein (Jeffrey) provided his name to [REDACTED] as he came in the

room with a towel wrapped around him. After entering the room, he dropped the towel and laid on the massage table. ██████ said she did not know that she was there to give him a massage, but ██████ she proceeded to give him a massage. Jeffrey attempted multiple times to place her hands on his private parts. She informed him, this is not why I am here. ██████ was there for about an hour, Jeffrey stood up and left \$300.00 in the table, and then left the room.

The next day, ██████ contacted FNU LNU and asked her if she "liked being a pimp" jokingly. FNU LNU did not like her comment, and told ██████ that Jeffrey did not want to see her again because she did not like to play the game.

██████ never spoke to FNU LNU again.

Note: ██████ believes she may be able find the name and phone number of FNU LNU, and the exact address of the mansion.
