On 07/03/2020, at 5:21:13 PM Eastern Time, [REDACTED] [REDACTED] [PROTECT
IDENTITY], [REDACTED]

[REDACTED], called the FBI National Threat Operations Center
(NTOC) to report solicitation for prostitution by Alexander Guest,
Jeffrey Epstein, and Ghislaine Maxwell.

[REDACTED] provided the following information:

[REDACTED] was an escort [REDACTED] from age 19 to 22 years old. One
client was NY socialite, Alexander Guest (Alexander), son of Lucy Douglad
"CZ" Guest. Alexander paid [REDACTED] \$4,000 a night for sex one night every
week for two years and gave [REDACTED] \$50,000 cash as a birthday gift.
Alexander stopped seeing [REDACTED] when [REDACTED] was 22 years old stating that
[REDACTED] was too old.

Alexander only liked young girls as sexual partners and fantasized about
having sex with 15 year old [REDACTED] ([REDACTED]). [REDACTED] advised
Alexander's ex-wife, Elizabeth Guest (Elizabeth) of the relationship with
Alexander. Elizabeth advised that [REDACTED]

[REDACTED]). Elizabeth advised that Alexander is associated with Jeffrey Epstein, and Alexander claimed to know President Clinton.

In a separate incident when [REDACTED] was 20 years old, Ghislaine Maxwell hired [REDACTED] via telephone and instructed to purchase a black bra and lingerie and meet Epstein. [REDACTED] and ten other girls, unknown identifiers and ages (UNSUBS2), massaged Epstein and gave him a "hand job". Epstein was cheap and didn't want to pay. [REDACTED] was paid \$300 for the hour. [REDACTED] returned home and Maxwell threatened via telephone [REDACTED] if [REDACTED] did not transfer \$150 to Maxwell's bank account. [REDACTED] [REDACTED] [REDACTED]. [REDACTED] transferred the money to Maxwell.

[REDACTED] stopped escorting [REDACTED] at 22 years of age.
