## Details:

On 07/23/2019, at 11:22 a.m. Eastern Time, [REDACTED]  
[REDACTED]  
[REDACTED], called the FBI National Threat Operations Center (NTOC) to report information regarding case no.: 31E-NY-3027571.

[REDACTED] provided the following information:

In the summer of 2002, [REDACTED] was introduced to Jeffrey Epstein by [REDACTED]. [REDACTED]  
[REDACTED] While [REDACTED]  
[REDACTED] and [REDACTED] were together at the Hamptons, [REDACTED] mentioned a dinner that was being organized at Epstein's house and invited [REDACTED]  
[REDACTED] to attend the dinner.

When [REDACTED] returned to New York from the Hamptons, she received a call from Epstein's assistant with information on the time and location of the dinner. [REDACTED] stated the dinner took place at Epstein's residence in the Upper East Side. When [REDACTED] arrived, she was met at the door by a butler and was informed that Epstein and [REDACTED] were upstairs waiting for her. The butler took [REDACTED] to a reception area where Epstein and [REDACTED] were waiting. [REDACTED] noticed that she was the only other person there. [REDACTED] asked [REDACTED] where all the other dinner guests were. [REDACTED] told her that they couldn't make it so it was just the three of them. [REDACTED] then

stated he had to leave and go back to his office and would catch up to [REDACTED] later. [REDACTED] told [REDACTED] that she was not expecting to be alone with Epstein and she was not comfortable and would not stay for dinner. [REDACTED] recalled stating to [REDACTED] that the whole encounter was like he was trying to pimp her out to his friends. [REDACTED] was able to explain the encounter away.

After [REDACTED] left Epstein's home, she received a few calls from his assistant attempting to invite her to back to the residence for dinner. [REDACTED] declined each invitation and eventually stopped taking the assistants calls.
