Details:

On 07/08/2019, at 2:07 p.m. Eastern Time, [REDACTED], date of birth [REDACTED], called the FBI National Threat Operations Center (NTOC) Unit, to report information related to the Jeffrey Epstein case.

[REDACTED] provided the following information:

In January or February of 2003, [REDACTED] close friend [REDACTED], personal identifiers unknown, currently residing in [REDACTED], 19 or 20 years old at the time, asked [REDACTED] if she would be interested in making some extra money. At the time, [REDACTED] and [REDACTED] were doing various modeling jobs in [REDACTED]. [REDACTED] stated a friend from New York introduced her into doing some massages for Jeffrey Epstein at his residence in Palm Beach, FL, and [REDACTED] wanted to know if [REDACTED] would be interested. [REDACTED] explained she had done a few massages and was being paid \$300. [REDACTED] asked [REDACTED] if she would be comfortable doing the massages topless, and [REDACTED] stated it would be fine.

After arriving in South Beach a few days later, [REDACTED] and [REDACTED] were picked up in a "SUV-type limousine" and taken to Epstein's home in Palm Beach. Epstein greeted [REDACTED] and [REDACTED] upon arrival, and [REDACTED] stated she was in awe of how nice the home was, which included a personal chef, numerous butlers, and a dance studio. [REDACTED], [REDACTED], and Epstein all sat together and had various conversation about various subjects. [REDACTED] stated she felt very comfortable talking to Epstein and [REDACTED] describes

it as "genuine conversation." Epstein spoke about buying his son a Volvo for safety, and also talked about formally being a teacher while in New York. [REDACTED] and [REDACTED] were eventually led upstairs to a large room with a bedroom attached, in order to prepare for the massage. Epstein wore only his boxers, as [REDACTED] and [REDACTED] began massaging his upper back, working their way down his body. Soon after beginning, Epstein asked [REDACTED] to go downstairs and get some water. [REDACTED] walked downstairs, grabbing a FIJI water out of Epstein's "water refrigerator." [REDACTED] later told [REDACTED] while she was downstairs Epstein had confirmed both girls were comfortable giving the massage while topless.

Upon returning with the water, Epstein said "Ok girls tops off." [REDACTED] and [REDACTED] finished the massage, and were paid \$300 each. Epstein asked for [REDACTED] information and said "I would like to see you again." [REDACTED] and [REDACTED] left the residence and returned to their homes.

A few weeks later, Epstein contacted [REDACTED] by telephone, asking her if [REDACTED] would be interested in flying down to see him, and staying overnight. Epstein purchased a flight for [REDACTED], and she flew from [REDACTED] to Ft. Lauderdale. Upon arriving at the airport, [REDACTED] was greeted by two unknown men, and was directed to the side of the airport, towards a private helicopter. [REDACTED] was flown up the coastline, and taken to the Palm Beach Airport. [REDACTED] was taken by limousine to Epstein's home. Upon arriving, Epstein explained he had just arrived home from France. [REDACTED] noticed another unknown female with Epstein, [REDACTED] described as young, and potentially underage. The female stated she had traveled with Epstein to France, as Epstein stated both girls should travel with him in the future.

Later that evening, Epstein showed [REDACTED] to her room, and they ate dinner by his pool. After dinner, [REDACTED] gave Epstein another topless massage. During the massage, Epstein made an attempt to unbutton [REDACTED] pants, but [REDACTED] backed away. [REDACTED] felt uncomfortable and said "I am on my period." Epstein then allowed [REDACTED] to finish the massage, as he masturbated in front of [REDACTED]. Afterwards, [REDACTED] stated she had not felt good and went to bed early. [REDACTED] did not have any recollection after

going to bed.

█████ and Epstein had breakfast the next morning, and █████ gave Epstein another massage. During the massage, Epstein said "you know you don't have to lie about being on your period." █████ was very freaked out, and was unsure how he knew she was lying. After the massage, █████ told Epstein she had just recently become engaged, and Epstein stated "there are two things I don't mess with, married woman and minors." Epstein paid █████ \$600, and asked her to find other girls to come to his home. Epstein also critiqued █████ massages, and stated some of his other girls liked to go "continue going." Epstein stated one of his female assistants would follow up and █████ flew home. The next day, █████ received a book via US Mail titled "Massage for Dummy's."

Epstein followed up with █████ at one point, and inquired about bringing friends down to his residence, which ended up being the last time █████ and Epstein spoke. █████ is unsure if █████ returned to Epstein's home.

█████ stated at no point did Epstein force sex on her, but █████ remembered Epstein taking a Polaroid photograph while she was topless. Epstein stated he would send the photo's to a close friend which was the owner of Victoria's Secret. Epstein stated it the photo's would help land her a modeling job.
