Details:

On 07/08/2020, at 4:42 p.m. Eastern Time, [REDACTED] [REDACTED], date of birth [REDACTED] [REDACTED], called the FBI National Threat Operations Center (NTOC) to report [REDACTED] was a witness to the activities by Jeffery Epstein, Ghislaine Maxwell, and [REDACTED] in 1981 and 1982.

[REDACTED] provided the following information:

[REDACTED] stated in early 1982, Epstein and Maxwell, were flying a jet out of Las Vegas, taking girls and going to New Mexico, [REDACTED] said it was a "fuck" fest on the plane. [REDACTED] stated she had been at the airport waiting for the girls to go but [REDACTED] never went with on the plane because of her poor attitude. [REDACTED] stated there was sex all the way down to New Mexico, and they were supposed to go to some island in New Mexico. The information [REDACTED] received about this came from an unknown girl which went to New Mexico a couple times. In 1982, [REDACTED] stated there was a blue and white building, a child's body was buried under the building, and it's a mausoleum or a small building, in New Mexico. The unknown girl was terrified to report this to police, [REDACTED] does not have her name.

The person that introduced [REDACTED] to Epstein and Maxwell was [REDACTED], his fake name is [REDACTED] and [REDACTED] stated [REDACTED] was a former DEA agent. [REDACTED] stated [REDACTED] would do things to [REDACTED] and make her submissive to him. [REDACTED] stated [REDACTED] showed her a tunnel and it was

really big and is in the Ouachita Mountains in Arkansas. The entrance to the tunnel runs about 1,000 feet wide, you can drive right up to it, it's like a parking garage but it is under ground, pillars are wider than a normal parking garage. [REDACTED] drove [REDACTED] about 50 feet in and [REDACTED] took a picture of the tunnel. The tunnel is all cement and did not reflect any light. The tunnel would get darker the further you would go in. [REDACTED] stated she was with [REDACTED] for 2 years from February 1981 to October 1982. The address where [REDACTED] and [REDACTED] lived at was [REDACTED]. [REDACTED] stated she was 21 years old during this time. [REDACTED] stated she has a picture of her and [REDACTED] from when he had beaten her up. [REDACTED] stated [REDACTED] said they were looking for ghosts and no one can find him.
