Details:

On 03/19/2020, at 11:13:52 a.m. Eastern Time, [REDACTED] [REDACTED] ([REDACTED]), date of birth [REDACTED], home telephone number [REDACTED], home address [REDACTED], called the FBI National Threat Operations Center (NTOC) regarding his sexual abuse by his father, [REDACTED], and Jeffrey Epstein.

[REDACTED] provided the following information:

[REDACTED] maintained a friendship with Epstein prior to the provision of [REDACTED] to Epstein. However, [REDACTED] was unaware of how [REDACTED] initiated the friendship with Epstein.

Between approximately 1977 and 1980, [REDACTED] transported [REDACTED] from their home [REDACTED], to various places in New Mexico and Florida at the direction of Jeffrey Epstein for the latter's use of [REDACTED] for sexual acts. Epstein personally engaged in sex with [REDACTED] and provided the boy to other clients for their engagement in sex with him. Additionally, Epstein used [REDACTED] communication with females of approximately [REDACTED] age or younger and for assistance in instruction of the females in sexual acts. [REDACTED] failed to recall the cities to which he traveled, and he failed to recall identifiers for the other victims or Epstein's other clients.

In his conversations with [REDACTED], [REDACTED] referenced previously raping [REDACTED] from the latter's age of one year to three years old, and [REDACTED] continued his sexual assaults of [REDACTED] until approximately 1981. Additionally, [REDACTED] provided [REDACTED] to his coworkers for engagement in sexual acts.

In approximately 1981, [REDACTED] was discovered by [REDACTED] to be engaging in sexual acts with [REDACTED], prompting relocation of [REDACTED] to [REDACTED], where [REDACTED] began habitation with [REDACTED]. [REDACTED] subsequently relocated to [REDACTED]. In approximately 1981, [REDACTED] entered [REDACTED] into [REDACTED] in [REDACTED], wherein the resident priest, [REDACTED] raped him and subjected [REDACTED] to
