At [REDACTED], I was a stand in. I signed a contract as Chester CopperPot , possibly used my real name as Bob Kettles. When I left, someone asked if they could have used the name Chester Copperpot, I said I wasn't coming back & go ahead. There was a stripper there whose real name was Chet, nice guy, we didn't resemble each other, it wasn't him that wanted to use my name. I think I accidentally took a 15 year olds virginity, she could have passed as 25,

her mother brought her. I don't remember doing it. We were all told that no one under 18 was supposed to be there. if you put her next to the DJ's daughter, tell me which one is 15. I think someone spiked the punch with something. Women were giving me drinks. Everytime I ejaculated, towards the end of the night. No sex occurs in those places, show this to a female member of the FBI. I was just a stand in who wasn't test for STD's, one prior sexual incident, & donated blood a few times in between them, & told them I don't know if they notify when they test it. I made no money. I was raped that night, not at the bar. I finally remember. I got the [REDACTED] rescue squad to say, that is a legitimate rape around 7am 7/8/2020. i have trouble remembering anything. After I got a phone call from [REDACTED]. My neighbors Daughter Jessica Taylor, brought over a 15 year old, mentioned how it still hurt. she wasn't looking for Chet. That is the only time I remember seeing her is when she was brought over those few times. I can't remember if that girl was there but I asked Jessica what her story was, & was told she was 15. I told her to tell her not to do what ever those people asked her to do. no money is worth it. I was told she was only offered jewelry. I mentioned to someone my Royal ancestry, was introduced to Carla Sands at the club, people had broke in next door i think. Epstein's crew followed male strippers looking for 15y/o brought by their mothers. I don't know if the strippers knew.

He lived in Poutney VT when I worked at Hubberton Forge around 2007/2008. I hope the authorities were contacted after all this time, It seems I'm getting the run around with this rape case, almost 19 years.

I know there were other languages speakers there, maybe with Carla Sands, maybe from Middlebury College, maybe strippers wives or girlfriends. It was the first time I could use those languages, besides using my grandmothers CB base station, which was where I learned them.

I don't know if Epstein & Carla Sands are close, but I knew she knew he was there. Maybe she likes strippers.

I think Andrew maybe Haakon (i'm not sure, i know that Royal the best if you can get him to admit to it.). Giuliani may have been there too, may

not have been him. might have been in the building that was broken into. I know there were others Epstein was there. I know someone spiked the punch at one point. It may have been Bill. I don't remember seeing it, just told not to drink it. Women were giving me drinks telling me to keep my fluids up.

I remember someone had their ankle accidentally broke. I made no money that night. I gave over all the cash I had at the ned of the night, Jill Marr had my wallet (she did have permission to spend money, I only had \$200 anyways), I was given it back by Kelley Hall the next day. I couldn't show my ID to the EMT's when they drained blood which is usually done at the hospital, but the male EMT knew how to do it. So it fucking happened where those EMT's were called. There was a damaged cervix which i think a brunette EMT was looking at in a bedroom. It was my vomit on the sidewalk outside, it was my vomit out on the ice out back when i threw up off the bridge.

I don't know who used my alias Chester Copperpot. Joe Card rang a bell. I think he said I didn't recognize him.
