These individuals, as well as [REDACTED] [REDACTED] [REDACTED] have hacked all of my electronics/phones and even put a sophisticated

tracking device on my car. In September of 2018 while I was traveling [REDACTED] I was pulled over by several police officers, asked to come back to the station and as I was about to leave, 2 officers who had not been present prior arrived, handcuffed me and involuntarily committed me to a hospital [REDACTED]. I was there for 11 days. Since that time, I have been followed, phones cloned and hacked, screws thrown into my driveway; harassed, stalked, given poisoned food, etc. I have been to [REDACTED] only to be met with skepticism and accusations of being "mentally ill" and "needing help". Persons employed by [REDACTED] and who are directly involved with my family are [REDACTED]. I have only learned about my family's involvement in "mafia/mob" activities in the last year but it now makes sense but it is 50 years of puzzle pieces coming together. Others that are involved: [REDACTED]. My brother and father are brutal serial murderers. I believe I may know where some of their victims are buried. I have confronted my family, they know that I know everything. I am fearful for my life. Please help me. Thank you
