to reside in Moscow but visits here on a systematic basis. Former wife's nephew, Andrew X, would be very approx 30 y.o., resides to my dated knowledge in Moscow & continues to work for FSB. Fullname & mother's address in my archives. Submitted in FBI report of 5-6 years ago. One hour phone interview with NYC office, at which time I did not know the full extent of the Russian female group's penetration into my divorce life. They captured most of my email with my divorce lawyer. One member's email to my wife I intercepted by accident. In addition to a detailed analysis of my side of the divorce, it stated: "we" will target "Doug" (A disconcerting familiarity.) and "pull the trigger over and over". Russians don't typically use metaphor! The writer used email corporate letterhead, as the personal assistant to the Treasurer (?) of Smith Barney, NYC. I complained and she was ostensibly reprimanded. Another member of 14 was at Sandia Lab, now reportedly senior at Microsoft. My Wikipedia was expertly hacked & email fake enticements sent to frame me as philandering in marriage.

How is Contact Known: 1. Photo & possible further ID in stored studio archives, difficult to retrieve. No other present info. She was typical model age range 16-25. While extremely beautiful, too short for top NYC work, so I did photos as a favor. After some hours in my studio, she began to cry & said, to my recollection, she was Prince Andrew's girlfriend who had "thrown her out" of NYC domain. She was homeless and no money. I assisted as I could, but didn't see her again. I have only one photo now, but I did take many as she had a strong, photogenic presence. As above, requires difficult archives search.

2. Former wife, Oksana Katsuro Hopkins, now remarried; O.K. Villa. Have extended information, including my own brief contact with the Russian mafia in her hometown, a secluded, top science laboratory location. She was recruited and "semi-retained" by DC Naval Research Lab (NRL) where my father, Cleveland Hopkins, a top Q-clearance scientist, worked on early A-bomb tests. She failed FBI background check for nominal reasons & at that point initiated divorce. Married approx 12 years. These two issues are entirely unrelated.
