## Submitted Text:

When I was 6-8 years old and living at [REDACTED], I was drugged at night and driven by my father, [REDACTED] to pedophile ring "parties". The main house I was taken to is located behind [REDACTED], at the end of a private road. [REDACTED] is next door. In the driveway of this house, I was hit by a dark blue car with a personalised license plate ending in "D0Y", driven by Prince Andrew. I was not taken to hospital, but I suffered permanent injuries to my ribs, hip and leg on my right side. The car's hood figurine broke off in my hand on impact and I later buried it near my home, so it could still be recoverable as evidence. After I was hit by the car, I woke up to Prince Andrew forcing his mouth on mine and pushing my legs apart. He raped me. In that house, I was also sexually tortured with household tools and penetrated with a beer bottle. I have medical records of the resulting infection. I once ran away from the house naked, and made it to the [REDACTED] community down the road (GPS: [REDACTED]). I remember seeing and speaking to a man, so I think that there may be [REDACTED] living in the area who could corroborate what goes on there. ---- I was also taken to another house that I later recognised as [REDACTED]. There, I was restrained on a table and tortured with electrical shocks by Ghislaine Maxwell and surrounded by watching men. I remember seeing Prince Andrew's face. After being raped by another man there, I tried to sneak out. Maxwell caught me and beat me with the bristle end of a broom. She penetrated my vagina with the handle of the broom. She also threatened me, saying that I "deserved to die" and hit me in the face with the broom, breaking my nose. I was only taken to the hospital for the broken nose after a rugby match, so that the injury could be blamed on that.

Additional Info: During this time frame, I also went on yearly vacations [REDACTED], staying at my grandparent's house [REDACTED]. I remember on one occasion being driven by my father over an hour away to a mansion with a gated driveway and a large rectangular swimming pool. I was molested by a man that I later recognised as Epstein when he was in the news. He also attempted to rape me (but he could not force his round and misshapen penis inside my vagina). He took pornographic photographs of me in a skirt.

Around late 2012, I had not yet fully processed all these memories, but I reported my father to the police after seeing a text from G. Maxwell on his phone saying: "I have two children", and being triggered by it. I believe it's possible that my father may have been involved in procurement for the pedophile ring even then, because he made visits to several local schools and a disabled children's home [REDACTED] [REDACTED]. In the end, he was not arrested and the case was not investigated. As a result, he was able to destroy a lot of evidence, such as photographs. Releasing Ghislaine Maxwell on bail would lead to the same outcome.

I am willing to testify, and provide evidence and/or more detailed descriptions of events.

She is a year younger than me, so she may have been as young as 5 years-old at the time. Afterwards, she was taken out of an affluent private primary school and sent to the worst school in the area, where my mother worked. That was where I first recognised her, even though we had supposedly never met. She was put in a class two years ahead, and then went to the same Secondary School as me ([REDACTED] [REDACTED]) a year before I did. We have never once spoken.

How is Contact Known: [REDACTED] [REDACTED] is the daughter of [REDACTED] and my childhood friend. I remember [REDACTED] was at some of the parties with me, and I remember us once hiding behind a drape together. However, we have never discussed it, so I don't know what she remembers.
