On 07/29/2019, at 6:48 a.m. Eastern Time, [REDACTED]
[REDACTED], called the FBI National Threat Operations Center (NTOC) to report information regarding case no.: 31E-NY-3027571.

[REDACTED] provided the following information:

[REDACTED] stated she was modeling in New York City between 2002 and 2006, which is how she met Epstein. [REDACTED] said she was scouted out and remembers being told to contact Epstein's office. [REDACTED] said it seemed very professional. [REDACTED] stated a limo picked her up and took her to Epstein's mansion. [REDACTED] stated Epstein asked for a massage, but she declined. [REDACTED] stated Epstein then called Trump and had a conversation with him while he was on the massage table. Epstein told her he managed Trump's, Bill Gate's and Victoria Secret's money. However, [REDACTED] does not know if this is true.

[REDACTED] stated Epstein gave her \$200, even though she did not give him a massage or have sexual intercourse with Epstein. [REDACTED] asked why he gave her the money, and he said I just like being generous. [REDACTED] stated she kept in contact with him after that and every time she met with him he gave her money. [REDACTED] never had sexual intercourse with Epstein, they only had tea and discussed politics. [REDACTED] said they attended concerts at Carnegie Hall and [REDACTED]. [REDACTED] stated they attended an after party, which is where she met Trump and Malania Trump.

Epstein asked [REDACTED] if she would wanted to be the mother of his children. [REDACTED] stated he did not want a relationship with her, but wanted it to be a business deal. Epstein would get her nannies and a mansion in Beverly Hills. [REDACTED] said no to the proposition, and asked him why he would ask her that. [REDACTED] said Epstein told her it was because of her genetics, she did not do drugs, and because he liked her personality.

[REDACTED] [REDACTED] said she knows aggressive behavior and Epstein is not that type of person. [REDACTED] stated all the times they spent together, he was such a gentleman and was never aggressive. [REDACTED] said Epstein told her he just wants to help women.

[REDACTED] said there was a time where she met a young girl, about 19 years old, from Brazil, at Epstein house. [REDACTED] asked Epstein why she was there, and he told her it was parental consent. [REDACTED] said it did not seem she was there for sexual purposes. [REDACTED] also said she asked Epstein why he liked younger girls and he told her he was petrified of germs and older women have germs.
