On 09/10/2019, at 5:44 p.m. Eastern Time, [REDACTED] ([REDACTED] [PROTECT IDENTITY]), date of birth [REDACTED], cellular telephone number [REDACTED], called the FBI National Threat Operations Center (NTOC), to provided information regarding Jeffrey Epstein, main subject in case number 31E-NY-3027571.

[REDACTED] provided the following information:

[REDACTED] was a professional dancer and model in the 1990's. She was friend and roommate with another professional dancer and model, [REDACTED] [REDACTED] in New York. [REDACTED] said she was only 22 years old back then.

[REDACTED] told [REDACTED] she had been working for Epstein and had traveled all over the world, including Europe and the Bahamas, he was a man that appreciated it dancers and he was looking forward to sponsor a ballet company.

On 07/02/1991, [REDACTED] went to the Jeffrey Epstein's office located at 457 Madison between 50th and 51, she clearly remembers it was the 3 building on the left. [REDACTED] told [REDACTED] to ask for Paula. [REDACTED] entered the office, a woman on her desk ushered her to another office where she met Epstein.

██████████ was awestruck because the office didn't look like the office of a rich person. Epstein opened a desk drawer from where he withdrew a book of massages and gave it to ██████████. ██████████ remember that ██████████ told her that Epstein trained her how to massage him.

██████████ told ██████████ all was legit, nothing bad about it. ██████████ said she trusted ██████████ because they worked in a cruise ship for 5 months and have lived for one year in the same apartment.

Epstein wanted ██████████ to learn how to do massages. Epstein told ██████████ to call him back on 07/08/1991. On 07/09/1991, at 7:00 PM, ██████████ met Epstein at a different location in New York.

Epstein came out wearing a white robe. ██████████ asked him why he wanted the services of a ballet dancer if there were so many professional masseuses that could do a better job. Epstein told ██████████ he was impressed of how well dancers took care of their body, Epstein even did a very goofy "plie"

Epstein said "I understand how dancers are very comfortable with their own bodies. They are not afraid of nudity, and while talking about that, he undressed completely and lied on the bed facedown. ██████████ was uncomfortable with this, yet she didn't know what to do, she trusted ██████████, there was nothing wrong about it.

Epstein told ██████████ when she started massaging his back "close your eyes, blind people are the best doing the massages, they can visualized every bone." Epstein turned over and said "I have traveled all over the world, you can find places where one person is massaging your shoulders, one of your middle and one your lower part.

Epstein asked [REDACTED] to take her clothes off and said "let me show you how you need to do it" Epstein was talking to [REDACTED] saying one thing and doing another thing, very blatantly. Epstein bit her legs, masturbate on her and threw the money and left.

[REDACTED] was in shock, didn't know what to do. She contacted a friend that told her to call the local police because she had been sexually assaulted. [REDACTED] was afraid because she thought nobody would believe her.

[REDACTED] told [REDACTED] what happened, [REDACTED] never talked to [REDACTED] again. [REDACTED] later on contacted common friend [REDACTED] to try to lure her into meeting Epstein. [REDACTED] didn't comply.

[REDACTED] kept this secret for 30 years. [REDACTED] finally shared what has happened to her after she read the confession of one of Epstein's first victims. [REDACTED] said she felt free when she shared this burden with her husband and her mother.

[REDACTED] said [REDACTED] needs to be held accountable because she was an enabler. [REDACTED] seems to want to disappear and keep a low profile because she doesn't have a social media account.

[REDACTED] last saw [REDACTED] the day of her wedding in [REDACTED] when [REDACTED] just showed up without being invited.
