Details:

On 07/17/2019 at 2:54 p.m., Eastern Time, [REDACTED] [REDACTED], date of birth [REDACTED]
[REDACTED], called the FBI National Threat
Operation Center (NTOC) to report she believes she was sexually assaulted
by Jeffrey Epstein in 1974.

[REDACTED] provided the following information:

In 1974, [REDACTED] [REDACTED] had been [REDACTED]
[REDACTED]. [REDACTED] took [REDACTED] to New York City to spend
the summer with [REDACTED].

[REDACTED] reported she asked [REDACTED] for money for ice cream. [REDACTED] refused so
[REDACTED] went door to door asking for money. [REDACTED] spanked [REDACTED] and sent her
outside. [REDACTED] was outside crying when Epstein, (stated his name was
Jeff,) who she believes was in his 20's, pulled up in his car. Epstein
asked [REDACTED] why she was crying and gave [REDACTED] five dollars for ice cream.
Epstein asked [REDACTED] to come sit in his car after she got her ice cream.
Epstein told [REDACTED] he was a teacher. Epstein asked if he could take
pictures of her. [REDACTED] allowed Epstein to take non sexual pictures of her.

Two days later, Epstein came back, and ask [REDACTED] to sit in his car with
him. Epstein took more non sexual pictures and asked [REDACTED] to pull her
underwear to the side. [REDACTED] said "no." Epstein then said "The first
lesson in life you'll learn, is you don't get nothing for free and I gave
you money." Then [REDACTED] pulled her underwear to the side and Epstein took

pictures of her genital area. Epstein removed his penis and asked [REDACTED] to massage it, by placing her hand on his penis. [REDACTED] told Epstein that [REDACTED] would be looking for her and she needed to go. Epstein then gave [REDACTED] twenty dollars and [REDACTED] exited his car. The next day, [REDACTED] returned to take [REDACTED] home. [REDACTED] stated she has never returned to New York. [REDACTED] was unsure of her exact location while in New York City.

[REDACTED] requested her pictures be destroyed if her pictures are found.
