On 07/08/2019, at 5:50 p.m. Eastern Time, [REDACTED] [REDACTED] ([REDACTED]), date of birth [REDACTED], called the FBI National Threat Operations Center (NTOC), to report information regarding case number 31E-NY-3027571.

[REDACTED] provided the following information:

In the year 2000, [REDACTED] was [REDACTED]. Approximately in August 2001-2002, a woman with short brown hair, about 5'7" enrolled [REDACTED]. The woman stood out because she was very late, basically 15 minutes [REDACTED]. [REDACTED] tried to be very accommodating and allowed her to [REDACTED]. [REDACTED] though she was [REDACTED]. The woman was wearing a fur vest.

The woman approached [REDACTED] and said "I want you to treat my boss and a friend of mine, she is a model." [REDACTED], up to this point, was led to believe the man he was going to see was a "marketing mogul for Victoria's secrets."

[REDACTED] got a call from the woman and was provided the address where to go on the Upper East Side. [REDACTED] walked over a "massive town house, near Madison and 5th" [REDACTED] was greeted by the same woman from her class, she

was wearing the same fur vest. A butler and a maid, wearing the traditional black and white outfits, greeted ██████ as well.

The boss was running late. ██████ was directed to his gymnasium. ██████ got inside a very ornate elevator where she noticed a collection of the Hardy Boy books, which ██████ found very strange. The gymnasium was red, with plenty of weights and cardio equipment. ██████ passed to the adjoining Yoga room that had a very large Buddha statue. ██████ saw two French figurines that looked "very sadistic," one figurine gave the impression of laugh while pulling the other figurine braids, depicting the second one like it was crying.

The boss, a medium height man, gray hair and wearing a purple Polo shirt greeted ██████ and told her he needed his back cracked because he was having back issues. The male, which ██████ now is 100% sure was Epstein, told her "You can hurt me."

██████ didn't feel comfortable adjusting someone with back issues. The man offered to adjust ██████ back. The man gave ██████ the business's card of his private Chiropractor. ██████ followed the man to a room full of oil paintings, paid her in cash and after that she exited and left the house. ██████ never heard from them again.

██████ believes the woman that contacted her initially was Mrs. Maxwell.
