## Details:

On 07/12/2019, at 8:11 a.m. Eastern Time, [REDACTED] ( [REDACTED] ) [PROTECT IDENTITY], date of birth [REDACTED], called the FBI National Threat Operations Center (NTOC) to report being a victim of Jeffrey Epstein Human Trafficking.

[REDACTED] provided the following information:

[REDACTED] stated that she was a victim of Epstein in the 1980's. She said, "I was one of the oldest victims and was much younger than any of them. My memory is splintered, I have shadows of memories. I have a lot of details by my memory..."

[REDACTED] reported being drugged and trapped. She said they cover for each other and lie.

[REDACTED] said that her biological mother, [REDACTED] ( [REDACTED] ) lost custody to [REDACTED] and her sister. Custody was given to [REDACTED], [REDACTED] supposed biological father. [REDACTED] married [REDACTED] ( [REDACTED] ). [REDACTED] would go to work and [REDACTED] brothers [REDACTED] ( [REDACTED] ) and [REDACTED] ( [REDACTED] ) would molest her. [REDACTED] would host crab boils and barbecues inviting "key people". [REDACTED] would be sent inside for something and while "lookouts" were in the kitchen taking care of anyone who entered, [REDACTED] would be in another room being molested.

[REDACTED] added that she and other girls would be taken by Jonboat to a yacht.

They were drugged but she remembers once when she referred to the yacht as a boat being punched. [REDACTED] said this took place in Florida.

[REDACTED] said that she didn't realize until she was an adult that she had been sex trafficked.

[REDACTED] also added that during this time the Ku Klux Klan (KKK) threw a brick threw the window of her home and burned a cross in her yard.
