his front yard. in the next few weeks he had his driver, his name was frank, ask me to go on a trip to costa rica with him. I was hesistant but wanted to go. We were on a yacht. he paid me \$5,000 to be topless the entire time and in a thong, and give him lots of massages. After I got back to [REDACTED], he had frank ask me again to go. I initially didn't want to because I was grossed out but frank called back and said I could bring one of my friends. so I said ok. and we both went. my girlfriend and I got really drunk, and he had sex with both of us. he made me pinch his nipples. we never spoke again. but I remember a few encounters where his brother was there, and a woman. the woman was mean. she used to tell me he didn't like me, she wanted me to go on dates with other people. I told her no. I never knew his last name, just knew him as jeff and his brother as mark. He told me he owned Kenneth cole.
