Interim Report of Investigation

On July 25, 2019, investigators received a phone call from [REDACTED] who was referred by Polaris to Hope for Justice, Nashville, TN. [REDACTED] stated she had been sexually trafficked by Jerry Edward EPSTEIN when she was approximately 5 years old and again when she was 17 years old. [REDACTED] wanted to know if her allegation could be investigated. [REDACTED] was contacted by Hope for Justice's Team Lead, Richard Schoeberl, who set an appointment with [REDACTED] for an interview on July 26, 2019.

On July 26, 2019, [REDACTED] SHE further provided her "parents", [REDACTED], trafficked her from a young age and had sex with her on a daily basis. [REDACTED] stated she has [REDACTED] brothers, [REDACTED]. [REDACTED] recalled being forced to live under the house in a crawl space and at times her brothers were made to live there as well. SHE stated at around the age of 5-6 years old [REDACTED] SHE was taken to Florida where [REDACTED] trafficked her to EPSTEIN. SHE recalled there was a number of young kids there and would recognize the area if seen again. SHE remembered being forced to have sex with a dog in front of EPSTEIN.

[REDACTED] further stated when she was 17 years old [REDACTED] took a Royal Caribbean Cruise to the U.S. Virgin Islands where she was "sold" again to EPSTEIN. During this encounter with EPSTEIN, [REDACTED] recalled being taken downstairs to a room that looked like a horse stall that had short walls where she and other little girls were viewed and forced to have sex with EPSTEIN and other men. SHE recalled one man in his 30's, with brown hair and wheel chair bound, who gave instructions to the other men as to what they should do to the girls. [REDACTED] stated for a while she was chained and berated by

the time. I was taken to an underground location. I was blindfolded so I would not know exactly where I was at. It was dark, and when we went through doors. We went downstairs, there was also an elevator in the location. I was kept in a stall, it looked like a horse stall that had short walls on the sides so you could see inside. It wasn't really to keep me and the other little girls inside it was to make it where we could be viewed. Epstein would walk past each girl including myself with a lot of men following him, and they would judge us. He told me I was "fat and ugly". So that's what he called me. He forced me to have sex with a dog, and he said I had to pretend it was him to see if I performed well. He said if I performed well I could be his girlfriend, then I would be allowed to be upstairs he called it. He said the girls upstairs were pretty and they were his girlfriends. He then raped me, and said I was evil because I liked it. I couldn't make my body stop feeling, so he said I had to go to the holding place to pray hard enough to be able to be upstairs with the other girls. There were a lot of pictures of girls naked all over the walls. I had to pray hard to be like them he said. The girls that he said performed well enough, went with the line of all of the men and they left. I was chained up.

In Virgin Islands, I was on a Royal Caribbean Cruise ship, they stopped there. I was 17 years old, [REDACTED] I was blindfolded and taken to an underground location. It had steps that went down. I was raped by Jeffery Epstein, there were other men that raped me. I was kept in a stall so that men could look at me. He said I was an animal and that he was perfect, if I had sex with him that I wouldn't be such an animal. I was chained up. He said I wanted to be raped because I wanted to be more like him.

I was shocked with an electric machine in my head. I was told I was evil constantly. For example I would walk out of the room they killed the fish that was in the fish tank, when I returned to the room, they said "why did you kill the fish?" They made me think I was so evil I did bad things and I didn't remember doing it. The psychological abuse was constant every day all through the day.

Multiple times. He was threatening to kill and harm other children if I didn't do what he said. He had video cameras he said, and if I didn't do what he said they would see that I caused the other children to get hurt. Then I would be put in jail.

We do not attempt to work cases that do not fit the Human Trafficking criteria of compelling someone to work; or, to engage in a commercial sex act through **force, fraud or coercion**. We work cases and turn them over to law enforcement and to prosecuting attorneys after we have gathered enough **evidence** to justify an arrest of the trafficker. **Evidence** is key, without corroboration of statements, cases cannot be prosecuted.

I was born into sex trafficking. I was trafficked beginning at my earliest memory. I do not remember a time that I was not trafficked for sex.

There were many men that were brought to their home to have sex with me. I was taken to many states in the US to sell me. I was forced by threat by [redacted] and Jeffery Epstein of being killed, bodily harm, and threats of harming other children if I did not have sex with them and any other people that they sold me to. The rape and sex trafficking with Jeffery Epstein happened [redacted] I was about 5-6 years old at
