[REDACTED] is from [REDACTED] and has lived in various places to include [REDACTED]

In 2001, [REDACTED] was living in [REDACTED] California and put an ad in Craigslist for a roommate. [REDACTED] responded so [REDACTED] interviewed her. [REDACTED]", but her name is [REDACTED] [REDACTED] then moved in with [REDACTED]. [REDACTED] and [REDACTED] became best friends. [REDACTED] told [REDACTED] that she was working for GHISLAINE MAXWELL. [REDACTED] lived with [REDACTED] for approximately a little over a year and a half - from the end of [REDACTED] [REDACTED] moved out after [REDACTED] had [REDACTED] [REDACTED] felt this was because she could not do anything career wise for [REDACTED] anymore.

[REDACTED] talked about a time where she met PETER NYGARD. [REDACTED] knew this world. [REDACTED] told [REDACTED], [REDACTED] let's go to this party." They went to this party where [REDACTED] thought NYGARD tried to traffick them. This party was at NYGARD's house in Marina Del Rey. When they arrived at the party, a secretary took their driver's licenses. It took around a half hour for them to get in. When they walked in, there were girls everywhere. They had drinks. NYGARD yelled at them to come over to talk and flirt with his guest who was a track star. [REDACTED] could not remember the track star's name. [REDACTED] told [REDACTED] they needed to leave. [REDACTED] did not drink the rest of her drink and wanted to get out of there. When they left, [REDACTED] was furious and screamed at [REDACTED].

[REDACTED] had email communication with [REDACTED] about knowing [REDACTED]. [REDACTED] also read in a Jane Doe's deposition that [REDACTED] gave massages. The more [REDACTED] read, the more she realized that [REDACTED] had to have been involved. It clicked for [REDACTED] about a year and a half ago that [REDACTED] must have been involved.

[REDACTED] was always secretive about MAXWELL. [REDACTED] told [REDACTED] that she signed a non-disclosure agreement. [REDACTED] spent a lot of time in her bedroom with the door shut and claimed to be working.

[REDACTED] and [REDACTED] were best friends. [REDACTED] loved her. [REDACTED] was a huge opportunist. [REDACTED] gave [REDACTED] some of her acting contacts.

[REDACTED] thought [REDACTED] had been told to keep quiet.

When [REDACTED] moved out, she moved in with [REDACTED]. [REDACTED] liked Asian girls so [REDACTED] became friends with Asian women and had threesomes with [REDACTED].

[REDACTED] was very vocal when she would spend time with MAXWELL. MAXWELL paid for [REDACTED] Lasik surgery. [REDACTED] also thought MAXWELL paid for [REDACTED] breast implants.

[REDACTED] recalled when [REDACTED] had left clothes in the New York mansion. MAXWELL told [REDACTED] that she needed to get her stuff out of there.

[REDACTED] helped [REDACTED] after her accident but she also used [REDACTED] for the people she knew.

[REDACTED] emailed [REDACTED] asking what she had gotten herself into but never heard back. [REDACTED] also emailed [REDACTED] asking him if he thought she was involved. [REDACTED] found [REDACTED] a pro-bono lawyer in London. *The Daily Mail* follows [REDACTED] around everywhere.

[REDACTED] contacted attorney [REDACTED] to talk to her about NYGARD and [REDACTED].

[REDACTED] told [REDACTED] that she was MAXWELL's assistant. [REDACTED] said she was

responsible for planning flights and organizing where they were going. Every time MAXWELL called [REDACTED], [REDACTED] would drop everything. [REDACTED] never met MAXWELL in person, but MAXWELL knew about her through [REDACTED]. [REDACTED] flew all over. [REDACTED] recalled [REDACTED] flying to New Mexico and Palm Beach quite a bit.

[REDACTED] was very outgoing, energetic, but did not use her head a lot.

[REDACTED] recalled watching a television show with [REDACTED] when DONALD TRUMP came on the television. [REDACTED] commented, "I was on the same plane with somebody," referring to TRUMP.

[REDACTED] had friends over, including KIRK DOUGLAS, a blonde girl that dated BRUCE WILLIS, women named [REDACTED] and [REDACTED] whose last names [REDACTED] could not recall. [REDACTED] recalled [REDACTED] was a brunette who was [REDACTED]. [REDACTED] friends came in and out. [REDACTED] spoke of her ex-boyfriend [REDACTED] who lived in [REDACTED]. [REDACTED] also had a cousin, [REDACTED] who visited. They would all hang out at [REDACTED].

[REDACTED] recalled [REDACTED] would send emails with jokes in them and MAXWELL was copied on the emails.

[REDACTED] told [REDACTED] that MAXWELL was very demanding. [REDACTED] was very secretive.

[REDACTED] recalled [REDACTED] flocked to people who had money. [REDACTED] was "all over" [REDACTED]. [REDACTED] was over a lot to spend time with [REDACTED].

When [REDACTED] traveled with MAXWELL, she would be gone for a long weekend to a week. [REDACTED] never thought much of it because [REDACTED] worked full time as a stand in 13 hours a day.

[REDACTED] and [REDACTED] friendship dwindled. [REDACTED] would come back to California without telling [REDACTED] which just reaffirmed to [REDACTED] that [REDACTED] was using her. They had a big fight over email.

[REDACTED] recalled [REDACTED] also hung out a screenwriter [REDACTED].
