[REDACTED], date of birth (DOB) [REDACTED] was interviewed pursuant to a proffer agreement at SDNY 1 Saint Andrews Plaza New York NY. Present for the interview was [REDACTED] attorney [REDACTED] (remotely over video conference), along with Assistant United States Attorney [REDACTED] [REDACTED], Assistant United States Attorney [REDACTED], Assistant United States Attorney [REDACTED] [REDACTED] and Detective [REDACTED] [REDACTED] (remotely over phone audio). After being advised of the identity of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] states she has pending claims with the compensation fund but is unsure if it's approved or denied yet. She is currently contacting others about corroborating her story for the fund. [REDACTED]

[REDACTED] states that [REDACTED] had witnessed [REDACTED] reading the book that was sent to [REDACTED] by EPSTEIN. [REDACTED] received a copy of this book around June or July of 2000. [REDACTED] emailed [REDACTED] recently to inquire about the book.

[REDACTED] met EPSTEIN when she was [REDACTED] years old in June of the year 2000. She remembers this because she had went to "Burning Man" around that time and [REDACTED] a month prior to her meeting EPSTEIN. She met EPSTEIN through [REDACTED]. She thought it was going to be a boyfriend set up. [REDACTED] said he is an older man in his 40's, he is rich and owns a private island. [REDACTED] was [REDACTED] and had hoped that EPSTEIN would help her with [REDACTED]

His secretary set up the first appointment to meet. She went to 71st street and met him inside of his study with [REDACTED]. She was at first let in by a butler and the waited to be called up. They sat on a sofa. EPSTEIN scanned through [REDACTED] portfolio. About 30 minutes later he brought them into a

massage room with red walls. There was a special massage table inside of the middle of the room. EPSTEIN tells them to take their clothes off. A sexual encounter occurs. Afterwards he gives them both \$200.

November of 2001 was the last time that [REDACTED] has ever seen EPSTEIN.

The second meeting with EPSTEIN was the next day. EPSTEIN had asked for [REDACTED] number previously. His secretary calls [REDACTED] and says EPSTEIN wants to offer her a scholarship. [REDACTED] goes to his house and the butler lets her in. [REDACTED] goes to the waiting room. Most times the butler then escorts her upstairs and she either goes to the massage room or the study. The second time she goes right into the massage room and there is no sexual interaction with her. [REDACTED] meets [REDACTED] who is giving him a massage at this time. EPSTEIN asks them if they know each other and [REDACTED] says yes. [REDACTED] pulls up a chair as asked by EPSTEIN and [REDACTED] gives him a normal massage. EPSTEIN offers [REDACTED] a scholarship to go to school with no strings attached. EPSTEIN suggests [REDACTED]. He says he has connections there and says the [REDACTED] is talented. [REDACTED] accepts the offer. EPSTEIN states the secretary will take care of it.

[REDACTED] takes 4 credit courses during the summer time, July classes that EPSTEIN paid for.

After this the interactions escalated.

EPSTEIN asked [REDACTED] to commission a painting. He says he can help her to go to "Burning Man". EPSTEIN says "I want you to paint a pussy" and he wants it to be realistic. [REDACTED] spends a month making the painting. She then calls [REDACTED] his secretary to say that its ready. The butler came to pick up the painting at [REDACTED].

EPSTEIN offers [REDACTED] an apartment at some point after the sexual intercourse. He would call her regularly. [REDACTED] had sex with him once. They go into his bathroom and they took a bath. He tells her to get naked and tells her to wash his feet. They go into his closet. EPSTEIN shows [REDACTED] his clothes and shoes. They go into his bedroom and have sex.

On one occasion [REDACTED] goes into the massage room and [REDACTED] was already in there. [REDACTED] was a massage therapist from Florida. EPSTEIN asks [REDACTED] to give [REDACTED] oral.

[REDACTED] moved into a space at East 66th street apt 7J. EPSTEIN had called his brother MARK EPSTEIN to check for the apartments.

[REDACTED] describes the massages in general as she would go into the massage room. EPSTEIN was usually not alone. He wanted her to have sexual interactions with other women.

[REDACTED] was older than [REDACTED], she was in her late 20's and blonde.

[REDACTED] brought a friend named [REDACTED] who she met after "Burning Man". She didn't know they were going to go to the massage room. A sexual interaction happened in the massage room after they left the study.

[REDACTED] saw [REDACTED] name in EPSTEIN's black book.

Nothing happened with [REDACTED]

There was a sexual interaction that happened with [REDACTED] [REDACTED] [REDACTED] was present for this inside the massage room.

[REDACTED] had seen [REDACTED] 4 times over 6 months. The first time she meets [REDACTED], [REDACTED] received a phone call from [REDACTED] the secretary. She says that [REDACTED] has to take someone shopping. [REDACTED] meets [REDACTED] in the kitchen. EPSTEIN says that they are to go meet MAXWELL to go shopping. EPSTEIN says that [REDACTED] is 17 years old. [REDACTED] did not ask. [REDACTED] recalls meeting the butler who drove them to a Manhattan town house that was under construction. [REDACTED] and [REDACTED] go inside and there are lots of people in there. [REDACTED] leads [REDACTED] to MAXWELL. MAXWELL looked at [REDACTED] and says "go find a little school girl outfit" and then says to [REDACTED] you know where to go? MAXWELL gives [REDACTED] a few hundred dollars.

They then go to Saint Marks street as directed by [REDACTED]. They go to a clothing store. [REDACTED] picks out an outfit that has ruffles and balloon sleeves. It has a skirt part of the dress. [REDACTED] gets a top and [REDACTED] gets her belly button pierced. She convinced [REDACTED] to get her belly button pierced as well. They then go back to EPSTEIN's but [REDACTED] does not go inside.

[REDACTED] may have met MAXWELL one time prior in the waiting room at EPSTEIN's. She says "Oh you're [REDACTED], you're all Jeffrey talks about". MAXWELL had a high pitched English accent. She was thin with short dark hair. She

dressed casually but in expensive clothes.

The second meeting with [REDACTED] was in the house in Florida. EPSTEIN asks [REDACTED] to come over. Then he asks her to go to Florida. [REDACTED] says yes. This was in March of 2001 during the Oscars. Her parents drop [REDACTED] off at EPSTEIN's house. She waits for the rest of the people to get there. She meets [REDACTED] and meets EPSTEIN. They go to the airport. They are taken via an SUV. They then take EPSTEIN's private jet. On the jet is [REDACTED], [REDACTED] (EPSTEIN's ex), MAXWELL and EPSTEIN. They go to Palm Beach for 5 days.

[REDACTED] meets [REDACTED] in Palm Beach. She was a love interest of EPSTEIN's. [REDACTED] spent a lot of time with [REDACTED].

There was a housekeeper in palm beach. A 2 car garage. MAXWELL drove a Mercedes convertible that was in the garage. [REDACTED] sees [REDACTED] there. [REDACTED] is taken to a yellow bedroom and is told that it belongs to the chef. [REDACTED] offers [REDACTED] a massage.

The second introduction to [REDACTED] was in Palm Beach by the pool. [REDACTED] blows kisses at EPSTEIN. EPSTEIN was excited to see her. [REDACTED] tells [REDACTED] about their sexual relationship. She says she danced with a prince and met a queen. EPSTEIN tells [REDACTED] about a Thai massage and describes going to Thailand and having sex with a 12-year-old massage therapist. (EPSTEIN later finds out that [REDACTED] told people and he yells at her and threatens to cut her off.)

Another time [REDACTED] saw [REDACTED] outside EPSTEIN's Palm Beach house with her boyfriend. [REDACTED] was a tall blonde girl about 17/18 years old. The boyfriend came to pick her up. She walked out of the house with her friend.

[REDACTED] went out in Florida with MAXWELL. They went to Mara-a-lago. They went to the tennis court. [REDACTED] and [REDACTED] watch MAXWELL and EPSTEIN play tennis and throw insults at each other. EPSTEIN then started to dry hump [REDACTED] and everyone laughed. They then brought them back to the house.

They took them to a boat show (EPSTEIN, [REDACTED], MAXWELL and [REDACTED]). They looked at yachts. It was a very hot day and MAXWELL and EPSTEIN walked ahead of them as they followed behind.

The 4 of them went to the movies. EPSTEIN sat next to [REDACTED]. A man in his late 50's sat next to [REDACTED]. EPSTEIN rubbed [REDACTED] leg. After the movie was over EPSTEIN asks [REDACTED] about the book that he gave her 6 months prior. As they are leaving the stop at Barnes and Nobile. EPSTEIN gives [REDACTED] \$50 and tells her to go inside and buy the book. EPSTEIN then shows the book to the other man in the car.

Inside of the Palm Beach house there were no private conversations with MAXWELL. [REDACTED], EPSTEIN, MAXWELL and [REDACTED] watched Oscars. MAXWELL mostly spoke with EPSTEIN.

At one point [REDACTED] is called up to the master bedroom by EPSTEIN. He says that MAXWELL wants to show her something and they go to MAXWELL's closet. [REDACTED] assumed it was her closet by the way she opened it. MAXWELL pulled out a sex toy and gives it to [REDACTED]. It was a latex whip with a strand. It was black and orange and she says I'm giving this to you.

One morning EPSTEIN tells [REDACTED] to meet him in his bathroom upstairs. There is an older blonde women nude in there. She is in her late 20's. EPSTEIN is nude. She is sitting on his leg. The woman says that she's no into that and asks [REDACTED] to leave.

[REDACTED] flew out of Palm Beach and back to Teterboro airport in New Jersey. On this flight was [REDACTED], MAXWELL, [REDACTED], EPSTEIN, [REDACTED] with [REDACTED] and the girl that was in bathroom. EPSTEIN had a phone call with someone saying that he will meet them at the Chanel store. MAXWELL made the travel arrangements on the flight. MAXWELL asks [REDACTED] where she lives. EPSTEIN asks MAXWELL if [REDACTED] is coming back to the house. MAXWELL says "no she's going home".

The third time meeting [REDACTED] was at the town house. [REDACTED] gives [REDACTED] a tour of the whole house. they use the elevator and [REDACTED] sees the guest rooms and the fitness room. [REDACTED] is introduced to [REDACTED] the [REDACTED] year-old virgin". She says that EPSTEIN is trying to have sex with her.

In Florida EPSTEIN said "I have to wait until she's 18 to fuck her" (referring to [REDACTED]). [REDACTED] says she takes showers with EPSTEIN. [REDACTED] says that her and EPSTEIN use the outfit all the time.

The 4th time [REDACTED] meets [REDACTED] was around August or September. [REDACTED] was

dating someone and not seeing EPSTEIN as much. [REDACTED] calls his secretary. She makes an appointment. She brings her friend [REDACTED] with her. The butler brings [REDACTED] right to the massage room. [REDACTED] and EPSTEIN are already in the room. [REDACTED] performs oral sex on [REDACTED] and [REDACTED] performs oral sex on [REDACTED]. [REDACTED] performs oral sex on EPSTEIN.

The last time [REDACTED] saw EPSTEIN was in late fall during the evening hours, she recalls it was cold out. They met in the study. EPSTEIN asks if [REDACTED] wants to get married. She does not answer. He asks [REDACTED] to have dinner with MAXWELL and 3 rich men. [REDACTED] agrees and then EPSTEIN takes [REDACTED] to the massage room. He tells [REDACTED] that they are going to do something different today. He tells her to take her clothes off and turns her around. He puts [REDACTED] down on the table and has anal sex with her. [REDACTED] did not like it. Afterwards [REDACTED] tells them she no longer wants to go to dinner. EPSTEIN was mad and upset with [REDACTED]. MAXWELL says hello. The last time she had seen EPSTEIN was so horrible.

MAXWELL had said to buy the school girl outfit when [REDACTED] and [REDACTED] were shopping. The store was a gothic/punk/ cos plays store. [REDACTED] thought it was a good store to take her to. She picked her own dress, [REDACTED] did not help. They sold lots of dresses and that's what she picked. It looked like a Japanese Cos Play type of costume. It was like anime, [REDACTED] is not sure if [REDACTED] tried it on. It was low cut, above the knee. It flared out and had a high waste line. It had short balloon sleeves and an underskirt. It had ruffles at the hem which may have been white. Maybe a light blue dress.

[REDACTED] thought that MAXWELL was the "first wife" of the harem. EPSTEIN gave [REDACTED] 2 books. One in English and the other in Arabic. They both had a red cover. EPSTEIN tells [REDACTED] what a harem is and says that she will be part of it. He says "you'll be part of Babylon" and "you'll be a favorite".

[REDACTED] was [REDACTED] and they had discussed harems.

EPSTEIN tells [REDACTED] he wants her to be a lot like [REDACTED]. [REDACTED] was described as EPSTEIN's ex-girlfriend.

MAXWELL was in charge of everything in Florida. She was territorial in the house. She would put a can of Maxwell House coffee in the kitchen.

[REDACTED] recalls having a conversation with MAXWELL by the pool. Her friend was

there who was foreign and married to a polo player.

EPSTEIN encouraged [REDACTED] and [REDACTED] to be topless. He told all the women to touch [REDACTED] skin. MAXWELL gives [REDACTED] a gift when they were in Florida. It was a perfume bottle.

In Florida there were 2 printed copies of the phonebook in the living room. [REDACTED] picked it up and flipped through it. It was not in alphabetical order. [REDACTED] was not in the book. [REDACTED] [REDACTED] and [REDACTED] [REDACTED] were in the book. It was a soft cover book perhaps black and white with some text.

[REDACTED] [REDACTED] She started having anxiety, depression and PTSD after EPSTEIN.

[REDACTED] [REDACTED] She was talking about EPSTEIN and reading a lot about him around that time. [REDACTED]
