Present for the interview were ██████████ attorney ██████████ along with AUSA ██████████ AUSA ██████████ and Detective ██████████. After being advised of the identities of the above listed individuals and the nature of the interview, ██████████ provided the following information:

AUSA ██████████ went over the proffer agreement with ██████████ and her attorney. ██████████ changed her last name to ██████████ after getting marry on ██████████. ██████████ was born in ██████████. Went to ██████████ University. After graduating college, she moved to ██████████, then back to ██████████. Also lived in ██████████.

1993, ██████████ met Jeffrey Epstein. ██████████ had a job as a regionals sales/ Student loan marketing. ██████████ was very good at math. ██████████ was looking to get a job in New York > ██████████ got a job offer, came to New York for an interview and met Epstein. Two weeks later ██████████ moved to New York. ██████████ was introduced to Epstein by a friend, but can't remember the friend's name. ██████████ would stop by Epstein's New York house and have conversations. The first time ██████████ got on Epstein's plane was during one of these conversations where ██████████ was telling Epstein about an accident she had, she felt and suffered from a concussion. ██████████ mentioned to Epstein that she was going to Florida. Epstein was going to Florida around the same time. ██████████ stated that she catch-a-ride, it wasn't planned.

██████████ moved back to ██████████. At this time ██████████ started talking to Epstein more. ██████████ got a job with ██████████.

██████████ stated that 1997 was the era of the ".com". Jeffrey Epstein became one of her biggest clients, she was his Financial Advisor. ██████████ would stop by Epstein's house located at El Brillo after work and talk about trade deals.

[REDACTED] helped Epstein purchased the Island. [REDACTED] has a property (Town House) in [REDACTED] which she sold in [REDACTED] [REDACTED] lived in [REDACTED] from 1995-2009.

[REDACTED] relationship with Epstein:

[REDACTED] stated that she went to books stores a lot, movies, and eating with Epstein. At the El Brillo' house, [REDACTED] would watch movies, eat and get professional massages. Epstein had two professional masseuse, [REDACTED] and [REDACTED]. The massages took place in the guest rooms, don't remember if there were other people in the room, she was always facing down. The Masseuse had massage tables. There were staff at the house doing cleaning and cooking. Epstein would say to [REDACTED] if she wanted a massage. Don't remember if Epstein was in the room when she got massages.

Interactions with Ghislaine Maxwell:

Ghislaine Maxwell would give [REDACTED] advice, Maxwell thought she was more educated than her. Maxwell let [REDACTED] know that she was Lady Maxwell, that's how she introduced herself to [REDACTED]. Maxwell told her no blue nail polish and no tattoos.

[REDACTED] stated that her relationship with Epstein changed after 9/11, because [REDACTED] left [REDACTED] and the accounts went back to Epstein. [REDACTED] was assigned to [REDACTED] from 1999-2000.

[REDACTED] met Prince Andrews went she went to the Island in 2000, and saw him again at Mar-a-Largo. [REDACTED] remembers going to the Island three times. [REDACTED] said she looked a another house with Epstein, then went to the Island to help with the purchase. The first time was to see the Island. The second time was a thank you visit and the final time was when Prince Andrews was there and she got an invitation from Epstein. During the thank you visit to the Island, [REDACTED] got massages, hung out with Maxwell and visited the other Island.

The Prince Andrews visit: [REDACTED] remembers Princess Andrews getting there in the middle of the night, helicopter coming down. [REDACTED] doesn't remember seeing [REDACTED] on the Island, but remembers seeing her on the plane on the way back. [REDACTED] stated that she remembers because [REDACTED] was rude. [REDACTED] was seating next to Prince Andrews on the plane and she was talking to

him. [REDACTED] gets up to go to the bathroom and [REDACTED] pushes her out of the way and takes her seat.

[REDACTED] also visit the Ranch and place in New York. Doesn't remember if Epstein was there went she visit the Ranch, the place wasn't done.

AUSA [REDACTED] asked [REDACTED] about an email she send on June 1, 2016. (Email attached to filed). [REDACTED] stated that the email [REDACTED] is in fact her email. [REDACTED] remembers the content of the emails regarding a civil matter, but doesn't remember the parts were she talks about [REDACTED]. [REDACTED] states that the only thing she remembers about [REDACTED] is the incident on the plane. On the email [REDACTED] talks about Maxwell sexuality. [REDACTED] had a hard time explaining why she said Maxwell is gay. [REDACTED] said that Maxwell hit on her, wanted [REDACTED] to kiss her, and cant remember if they kiss or not. Last time [REDACTED] saw Maxwell was 2003 or 2004. [REDACTED] doesn't remember seeing [REDACTED] at the Palm Beach house.

AUSA [REDACTED] asked [REDACTED] about her sexual relationship with Epstein. [REDACTED] stated that her sexual relationship with Epstein is her business, two consenting adults and she wasn't going to talk about it. [REDACTED] asked to speak to her attorney in private. At approximately 1342 hours left [REDACTED] in room with her attorney.

At approximately 1428 hrs, proffer resumed-

AUSA [REDACTED] asked about the Massage phone book (Attached to file. [REDACTED] said that she confronted Epstein when that book was first publish on the Internet. Epstein said that it wasn't his book. [REDACTED] said that she was upset the second time it came out on the article. [REDACTED] stated that she studied very hard and didn't like the idea of being listed as a masseuse on that book. [REDACTED] said that she got a call from a reporter about it.

[REDACTED] talks about her visit to the Island when Prince Andrews was there. Andrews. [REDACTED] was in the room next to Andrews's room, and it was more like "I was single, he was single, you may enjoy meeting him".

[REDACTED] stated that she doesn't want to talk about her sexual relationship with Epstein because of her marriage and kids. [REDACTED] said I had a relationship, didn't work and I kept him as a friend, it was an adult relationship. [REDACTED] and Epstein relationship was behind Maxwell's back. Epstein didn't discuss his relationship with Maxwell with me. [REDACTED] kept in contact with Epstein via emails and stopped seeing him early 2000.

[REDACTED] did have conversation with Epstein while he was in jail. Epstein said that he was doing counseling. BECK's understanding was that Epstein likes females [REDACTED] age or Maxwell's age.
