The first time [REDACTED] recalled JEFFREY EPSTEIN's name come into his life was around [REDACTED] give or take about two years. In [REDACTED] was in 9th grade. During the summer of [REDACTED] and [REDACTED] attended Interlochen for summer school. [REDACTED] thinks he heard of EPSTEIN's name during his last year of summer school which was [REDACTED]. After that, [REDACTED] did not visit Interlochen during the summer until [REDACTED] was attending Interlochen full-time during the school year between [REDACTED]

There was an EPSTEIN named lodge on the campus at Interlochen. [REDACTED] heard of EPSTEIN's name through Interlochen and also through [REDACTED] or [REDACTED]

[REDACTED]. [REDACTED]. [REDACTED]. When seeing EPSTEIN's face in the newspaper articles [REDACTED] felt as though it did not look familiar, but he felt as though he had met him before. [REDACTED] thought he would have met EPSTEIN on the main grounds of Interlochen but he was not sure. [REDACTED] may have met him in West Palm Beach but he was not sure. EPSTEIN's face was familiar enough that [REDACTED] thought he probably met him, but has no specific memory of it.

EPSTEIN's name came up with [REDACTED] when he arrived at Interlochen.

[REDACTED] was a classmate of [REDACTED] at Interlochen. She was a [REDACTED] who got the promise of a scholarship from EPSTEIN. [REDACTED] was not sure if she ever received the scholarship.

[REDACTED] was another classmate of [REDACTED] at Interlochen. She was [REDACTED] and [REDACTED] is still friends with her [REDACTED]. Sometime after Interlochen she called [REDACTED] and asked about EPSTEIN. [REDACTED] stated that she was somehow involved with EPSTEIN. [REDACTED]

Around [REDACTED], EPSTEIN's name came up in [REDACTED] as being a potential sponsor of artists and careers of promising young artists. [REDACTED] thought EPSTEIN wanted to sponsor [REDACTED] but he was not sure. [REDACTED] heard this from either [REDACTED] or [REDACTED].

EPSTEIN's name came up from time to time. [REDACTED] does not remember if EPSTEIN called the house. [REDACTED] recalled GHISLAINE MAXWELL's name coming up between [REDACTED]. This came from [REDACTED] [REDACTED] or from [REDACTED]. [REDACTED] also believed MAXWELL must have called and spoken to [REDACTED].

[REDACTED] recalled speaking with MAXWELL at least one time over the phone when he was in college in [REDACTED]. [REDACTED] recalled [REDACTED], who is a friend of his, possibly currently living in [REDACTED]. Around [REDACTED] she was about [REDACTED] years old [REDACTED]. MAXWELL called [REDACTED] dorm room and asked him if he could help her get in touch with [REDACTED]. [REDACTED] did not think he knew of her at the time but he reached out to her. He spoke to her in front of [REDACTED] and mentioned MAXWELL's

name. [REDACTED] did not want to speak with her and stated in sum and substance that she did not like what they were doing or what they wanted her to do. [REDACTED] said to his brother that they wanted her to give them a massage. [REDACTED] has a vague memory of this. [REDACTED]
[REDACTED].

[REDACTED] did not recall talking or meeting with MAXWELL. [REDACTED] recalled talking to [REDACTED] about how to pronounce MAXWELL's name. [REDACTED] knew of MAXWELL prior to starting college in [REDACTED]. He knew that MAXWELL was either an associate or worker for EPSTEIN. It is likely that [REDACTED] met MAXWELL.

[REDACTED] was asked if he recalled a member of his family going to EPSTEIN's home. [REDACTED] stated that [REDACTED] met EPSTEIN but he was not sure where. He know [REDACTED] met EPSTEIN more than once, multiple times likely but not sure how many. [REDACTED] was not sure about travel outside of town with EPSTEIN. [REDACTED] mentioned at one point that she traveled to [REDACTED] and met with EPSTEIN on that trip in the [REDACTED]. Possibly [REDACTED].

[REDACTED] was asked if he recalled gifts being given. He responded by saying no, but he recalled the discussion of scholarships being given, or possibly paying for arts education. [REDACTED] is not sure of any other employees of EPSTEIN.

Around June of 2019, [REDACTED] went to visit [REDACTED]. While there, they talked about her experiences with EPSTEIN. This discussion they had was around the time that some publication came out about EPSTEIN discussing how he recruited from dance schools. They may have also been talking about student loans. During this conversation, it was just the two of them. [REDACTED] did not go into specific details on what EPSTEIN did or asked her to do but [REDACTED] stated that she was part of the abuse that EPSTEIN was inflicting, and that he had done something. EPSTEIN had continued with this abuse until [REDACTED] started [REDACTED]. After that, it faded away and [REDACTED] distanced herself. BJOLRIN also discussed meeting DONALD TRUMP. During this meeting TRUMP said to EPSTEIN something to the effect of "you have got a good one". [REDACTED] did not mention MAXWELL during

[REDACTED] thinks that [REDACTED] must have been wanting to tell him. [REDACTED] had found out first and had told [REDACTED] but [REDACTED] had not spoken to [REDACTED] about it yet.

The Miami Herald did the first write up about EPSTEIN's deal which [REDACTED] was aware of. Prior to that, [REDACTED] recalled when the original investigation was occurring and reading about it somewhere. He recalled being upset about it because of the abuse of power. [REDACTED] emailed Interlochen around that time because EPSTEIN was convicted and he was still listed as donating money to them. He wrote this email because of EPSTEIN's conduct and the possibility of him conspiring to do this with [REDACTED] and other classmates of his.
