[REDACTED] ([REDACTED]) was interviewed over video conference by AUSA [REDACTED], AUSA [REDACTED] and Detective [REDACTED]. After being advised of the identity of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] grew up in [REDACTED] and went to boarding school in [REDACTED]. She then moved to [REDACTED] for college where she attended [REDACTED]. She currently lives in [REDACTED].

[REDACTED] has been friends with [REDACTED] since she was about 15 years old. They had always had gone to different schools. [REDACTED] dropped out at [REDACTED]. [REDACTED] was the same age as her or a year older. She may have still been in school when [REDACTED] dropped out. [REDACTED] had horses in [REDACTED] at the time. [REDACTED] met [REDACTED] through the social scene in [REDACTED]. [REDACTED] is the [REDACTED] of [REDACTED] and they are still friends today.

[REDACTED] does not recall [REDACTED] saying EPSTEIN's name specifically. [REDACTED] went to the island. [REDACTED] recalls MAXWELL called [REDACTED] a lot and invited her to parties and dinners. [REDACTED] remembers [REDACTED] had property in [REDACTED] at the time and [REDACTED] remembers these calls. [REDACTED] thinks these dates were prior to [REDACTED] getting sober.

[REDACTED] and [REDACTED] were inseparable at the time so [REDACTED] remembers her getting a lot of phone calls from MAXWELL.

[REDACTED] never met MAXWELL or EPSTEIN or spoke with them on the phone.

[REDACTED] recalls one conversation in which she could hear MAXWELL's voice through the phone. She was able to get the gist of the conversation

typically. [REDACTED] would have told [REDACTED] afterwards who it was or she would say "hello Ghislaine" when she answered.

[REDACTED] went on a trip to the island and wasn't herself when she returned. She was maybe still using but she never spoke about it with [REDACTED]. [REDACTED] said something about massages but they were using a lot. It triggered her drug use more often after she went to the island. She was more emotional after the fact.

A lot of [REDACTED] friends were friends of MAXWELL's and EPSTEIN's so she heard their names a lot. [REDACTED] were friends with them.

[REDACTED] told [REDACTED] recently, within the last 6-7 years, talked [REDACTED] about how the experience made her feel but did not go into detail. She talked about the impact on her. [REDACTED] does not have an understanding on what happened to her.

At the time [REDACTED] just thought MAXWELL was an older lady that wanted [REDACTED] at these parties. People of all ages were at these parties around this time in [REDACTED]

[REDACTED] believes [REDACTED] met MAXWELL at [REDACTED] house. [REDACTED] always had lots of eclectic people at his house for his parties. [REDACTED] has been to these parties but not that specific party.

At the time [REDACTED] went to the island it may have been before [REDACTED] but she's not sure. She may have been at [REDACTED] at the time.

HANSON and TIM JEFFREYS had a lot of parties at this time. HANSON was with SOPHIE ANDERTON at this time.

[REDACTED] started going to these parties at around [REDACTED] years old, pre-2003.

[REDACTED] met [REDACTED] on the [REDACTED] scene and stopped around 2004.

[REDACTED] sister is [REDACTED] years older than her and was friends with MAXWELL and EPSTEIN.

Phone calls happened when [REDACTED] had a flat in [REDACTED] Around this time [REDACTED] and [REDACTED] were going to a polo event.
