[REDACTED] ([REDACTED]) was interviewed over video conference by AUSA [REDACTED], AUSA [REDACTED] and Detective [REDACTED]. After being advised of the identity of the above listed individuals and the nature of the interview, [REDACTED] provided the following information:

[REDACTED] worked alongside [REDACTED]. She is concerned for her daughter's safety. She says that you pay a high price for standing up for justice.

[REDACTED] was born in [REDACTED]. She currently lives [REDACTED]. She works at an [REDACTED]. She takes care of her [REDACTED] sister and cousin.

She normally lives in [REDACTED] but moved to [REDACTED].

She first heard of EPSTEIN when she was living in [REDACTED]. [REDACTED] lived near MAXWELL at the time, around the corner.

[REDACTED] From [REDACTED] onwards [REDACTED] had difficult times.

While in [REDACTED] a young boy named [REDACTED]. The war was going on around that time and [REDACTED] feels that she took "my eye off the ball with my child". There was lots of tragedy around that time. There were deaths of family members. [REDACTED] had a miscarriage [REDACTED]. [REDACTED] was involved in the war [REDACTED]. There was a massive court case going on with [REDACTED] brother [REDACTED].

Her daughter [REDACTED] introduced [REDACTED] to MAXWELL while at [REDACTED], on the corner of [REDACTED]. This was in [REDACTED], and MAXWELL lived near Eaton Square in a little house. This was perhaps around the beginning of 1994. They were going between [REDACTED] and [REDACTED].

[REDACTED] After meeting MAXWELL, [REDACTED] recalls asking [REDACTED] "who's that?". [REDACTED] says that she has been really kind and nice to her. An alarm bell went off for [REDACTED]. That may have been the only time that [REDACTED] met her.

[REDACTED] was a happy child and then she started to change and became more distant from [REDACTED]. [REDACTED] was living with [REDACTED] at this time. She went to [REDACTED] around [REDACTED]. From [REDACTED] she went to [REDACTED] [REDACTED] moved to [REDACTED] permanently because of the court case.

When [REDACTED] was living with [REDACTED] she became distant. It was a tough time for [REDACTED] with everything going on. The [REDACTED] came up around [REDACTED]. [REDACTED] states that it's her fault because she took her eye off the ball with everything going on and she didn't protect [REDACTED]. [REDACTED] states she takes responsibility.

[REDACTED] was young when she introduced [REDACTED] to MAXWELL. This was around [REDACTED]. She recalls wearing light colored clothes and the sun was shining. [REDACTED] says that MAXWELL was being really kind and nice to her and says "Mommy stop it".

[REDACTED] was born in [REDACTED] so she was about 16 or 17 years old when [REDACTED] met MAXWELL. [REDACTED] always looked young, about 12 years old.

[REDACTED] said hello to MAXWELL at the time. [REDACTED] says "this is my mother; this is Ghislaine". [REDACTED] says hello and then MAXWELL hurried off. [REDACTED] ask [REDACTED] who is that. There was no other conversation that [REDACTED] remembers. [REDACTED] never met again or spoke with her on the phone.

[REDACTED] lived with [REDACTED] until about [REDACTED] years ago but she is not sure. [REDACTED] hasn't really discussed this much with [REDACTED]. They have been very close the last couple of years.

[REDACTED] knew something was happening because [REDACTED] was starting to be secretive and distant from her. This happened after [REDACTED] was introduced to MAXWELL. [REDACTED] was not like herself. She was dismissive and distant. [REDACTED] noticed this after meeting MAXWELL that she gradually got worse after this encounter.

On one occasion [REDACTED] says to [REDACTED] that MAXWELL would do anything for

EPSTEIN. [REDACTED] says this quite pointedly and without joy on her face. She said this back years ago after [REDACTED] had met MAXWELL. She did not say this happily.

[REDACTED] did not really know who EPSTEIN was at the time but she understood MAXWELL to be EPSTEIN's partner according to [REDACTED].

They did not have many conversations about MAXWELL and EPSTEIN. In the mid 90's [REDACTED] did not know anything about MAXWELL as she was very busy.

[REDACTED] was so careful in guarding [REDACTED] as a little child because things happened to [REDACTED]. At the time [REDACTED] understood that [REDACTED] was spending time with MAXWELL as part of the social scene. This understanding came from [REDACTED] asking [REDACTED] where she was going and she would say she was going to MAXWELL's because [REDACTED] [REDACTED] has a memory of [REDACTED] saying this to her. It was more than once that she said this to [REDACTED] but [REDACTED] cannot be certain the exact number of times she said this. [REDACTED] has not spoken to [REDACTED] about her experience with MAXWELL or EPSTEIN. Only when it came up publicly they chatted a bit. [REDACTED] spoke to a friend.
