During the time [REDACTED] was "working" for EPSTEIN it was repetitive - the same thing happened over and over again. [REDACTED] did not fly on planes or travel "like the other girls". [REDACTED] started seeing EPSTEIN when she was around 14.5 years old, just about to turn 15. [REDACTED] "worked" for EPSTEIN for about 2.5 years.

For [REDACTED] 16th birthday, her mother took her to the beach. Her mother took a photograph and one of the girl's in the photograph was the one who brought her to EPSTEIN. There are four girls in the photograph, from left to right was [REDACTED] (friend), [REDACTED] (cousin), [REDACTED], and [REDACTED], whose last name [REDACTED] could not recall. This photograph was taken at [REDACTED]. This was the first birthday party that was not shared with anyone else in her family. [REDACTED] mother enlarged the photograph and put it in a frame for [REDACTED]. This photograph was very accurate to what [REDACTED] looked like when she was going to EPSTEIN's house. This photograph was after [REDACTED] had already met EPSTEIN because she remembered having money at the time. This was posted on [REDACTED] Facebook page; [REDACTED] commented on it. [Agent note: Photograph is attached in a 1A.]

[REDACTED] has pictures of her from back around that age but not more with [REDACTED].

[REDACTED] and [REDACTED] were recruiting girls for EPSTEIN. [REDACTED] met [REDACTED] and [REDACTED] prior to meeting [REDACTED]. [REDACTED] guessed that [REDACTED] and [REDACTED] were working together because they recruited her. [REDACTED] went to EPSTEIN's home as well. [REDACTED] felt more like she was a work partner to [REDACTED] than a friend. [REDACTED] had a Facebook page named [REDACTED] and [REDACTED] do not talk regularly.

[REDACTED] remembered being at her aunt's house [REDACTED]. [REDACTED] was visiting family when she met [REDACTED]. [REDACTED] cousin [REDACTED] came home with [REDACTED]; this was the first time [REDACTED] met [REDACTED]. [REDACTED] and [REDACTED] talked and [REDACTED] asked her if she knew anyone who wanted to make easy money. [REDACTED] said she knew how to massage. [REDACTED] and [REDACTED] would do it. [REDACTED] and [REDACTED] picked [REDACTED] up to massage EPSTEIN. The first time [REDACTED] met [REDACTED] was at [REDACTED] aunt's house when [REDACTED] was there. They all hung out together and did drugs together sometimes.

[REDACTED] was not sure how long they had been friends before she went over to EPSTEIN's home. [REDACTED] recalled being financially stable by 15 years old as a result of going to EPSTEIN.

The first day that [REDACTED] met [REDACTED] and [REDACTED] they did not bring up massaging EPSTEIN. They brought it up later when they were at [REDACTED] mother's house.

[REDACTED] picked [REDACTED] up and took her over the bridge. [REDACTED] advised that people in her situation did not go over to the other side of the bridge. [REDACTED] had no idea what was going to happen. [REDACTED] had been sexually active but did not think that would happen. They got out of the cab. [REDACTED] recalled the sun was going down and it was a warm, nice day. [REDACTED] described the house as being huge. [REDACTED] was nervous; she did not know EPSTEIN. [REDACTED] was quiet and let [REDACTED] do most of the talking. A young woman, who did not speak English well, answered the door and said hello. They waited in the kitchen. GHISLAINE MAXWELL came down and said her first name, which [REDACTED] could not pronounce. They did not talk much. MAXWELL brought [REDACTED] and [REDACTED] upstairs. After this first time [REDACTED] went, she would go approximately 3-4 times a week and MAXWELL did not take her upstairs after that. MAXWELL was known at the time as the secretary of EPSTEIN.

[REDACTED] and [REDACTED] continued to be friends after this. They hung out and did drugs together. [REDACTED] and [REDACTED] had conversations about being at EPSTEIN's house and [REDACTED] knew that MAXWELL was that first person she met. EPSTEIN was the only one who wanted to get to know [REDACTED].

[REDACTED] described MAXWELL as having long shoulder length black hair that was an "80s style" with pale skin. [REDACTED] could not recall her voice. [REDACTED] described her as "cold". MAXWELL barely had any makeup on. MAXWELL talked with [REDACTED] the whole time. MAXWELL told [REDACTED] to pull the massage bed out of the closet, which [REDACTED] helped her do.

When they walked upstairs, it was MAXWELL, [REDACTED], and [REDACTED] where they walked down the hallway to the master bedroom and to the bathroom. They were talking at this time. They put the table in the center of the bathroom. [REDACTED] did not say anything. EPSTEIN came in the room with a a towel; he was on the phone. EPSTEIN introduced himself. [REDACTED] introduced

[REDACTED] after EPSTEIN got off the phone. MAXWELL was not in the room at this point. MAXWELL had left shortly after escorting them upstairs.

[REDACTED] was sort of uncomfortable that EPSTEIN was in a towel. EPSTEIN was on the phone for a while. [REDACTED] described it as being "awkward". [REDACTED] was instructed to massage his top while [REDACTED] was instructed to massage his bottom. EPSTEIN asked [REDACTED] to leave and things got really weird with him. [REDACTED]
[REDACTED]. [REDACTED] expressed being mad at herself now feeling that she never should have gone there again. [REDACTED] memory of it was very real and she does not like to talk about it. [REDACTED]
