In Oct of 2004, we were taken by bus to a miniature mansion in the Los Angeles, Hollywood, or Beverly Hills area for some sort of pizza party/dance. If research Boys Town, it was a annual Christmas tradition I think. But again, this was in Oct.

I remember a HUGE house with a stair case on each side... you walked into a dance floor

And there were TEEN GIRLS EVERYWHERE.
