██████████ ex was trying to help Isabell and Christine cover stuff up.

Me and my Ex ██████████ ██████████ were in Mexico for 6 months. Almost every day he was on the phone with Isabel. Sometimes she would get sloppy drunk on the phone calls. ██████████ would then poke Isabel for questions about GM. He would ask if she thinks that GM really did it. Isabel would say she believed GM did it but we have to cover it up. I overheard these conversations. Isabel said a couple times that GM did it. There's a bunch of documents and photos of what ██████████ believes to be underage girls that he would like to turn in to you guys.

██████████ never met Isabel, Christine or GM in person. He met Isabell and Christine over a zoom call when ██████████ was talking to them.

The last interaction was in June that ██████████ was present for. ██████████ would also zoom call with them from their apartment from New York. They would sometimes talk for hours.

██████████ said a while back him and his business partner developed this program in Australia. There ██████████ met JE. ██████████ said he sold this product to JE for 24 million. The software is called MOHO. ██████████ also got close to GM. Then he came back to the states.

Phone call ██████████ overheard GM to Isabel and ██████████.

██████████ is hiding stuff.

There is stuff on this hard drive. I work in accounting for feature films. I use this same computer for work. I use this computer to verify people's SS cards, id's, their "I9's". When I'm done I would delete these files from the computer. I came across these zip files that have tons of pics and documents that on the hard drive.

██████████ has previously showed me lots of these pictures previously from MOHO. Girls in tiny bikinis. I didn't go through these in depth because after viewing the first couple pics, I already knew what it was and it was connected to GM.

I saw a girl in a bathing suit on a beach. A girl coming out of the bathroom on her cell phone in her bikini, looked like she didn't know the picture was being taken of her.

These pictures are on an external hard drive that only I and ██████████ had access to. I had just gotten this computer at the time, and he was using my computer when we were in Mexico because he didn't trust the security down there. That's why he used my computer. He had to go through a VPN for his work. This was my personal computer.

I don't think there's other files related to GM on my computer but I can check.
