DJR: OK. We just got off the phone with your father, ah, he said it was OK for me to talk to you.

MD: No.

DJR: No. Ah, Tell me about a little bit about the second time. You went upstairs trying to provide him a massage.

MD: Hmm, mmm.

DJR: Did you massage his back?

DJR: At what point did he take out the massager?

MD: Ah, after I got taken off my shirt and ah, I, after, I found something to massage him and (UI)
