DJR: Today is October 04, 2005, this is ID number 7915, Detective [REDACTED] at the Palm Beach Police Department, present at 1301 C Road is Detective [REDACTED] of the Palm Beach Police Department and can you say your name for the record?

DJR: [REDACTED], can you spell your last name?

FP: [REDACTED]

DJR: How old are you?

FP: I'm 18.

DJR: 18. OK. You're currently in college?

FP: Yeah.

DJR: OK. What college are you attending?

FP: Ah, Valencia.

DJR: Valencia, OK. And your date of birth is?

FP: (Noise in the background) [REDACTED]

DJR: OK. Can you raise your right hand for me? You solemnly swear the whole truth, the whole truth and nothing but the truth so help you God?

FP: Yes.

DJR: OK. [REDACTED], if you can tell me from the beginning how you met Jeffrey Epstein. I know you have some information and we are conducting an investigation. Ah, there were here last night, ah, I spoke with your mom and dad, ah, if you can just start from the beginning as how you met him and how it came about.

FP: I met him through my friend [REDACTED].

DJR: OK. How long ago was that?

FP: Probably about (UI)

FP: And, ah, See, I went there once with her and to give him a massage and then she asked me if I wanted to do it and then I did it a little bit and then after that like he kind of scared me when I went there so I decided not to go back.

DJR: OK. The first time you went with [REDACTED]. Did you go upstairs with him?

FP: No. I stayed down at the kitchen.

DJR: OK. Did [REDACTED] tell you that, ah, what was entailed as to what had to be done?

FP: Well, she said that the first you got to give him a massage and then she said like the more it goes, the best for me, like the more he expects (UI) with girls then that's what it kind of scared me.

DJR: OK. I interviewed other girls and they told me pretty much about the same thing about the massage but there's more to that. Ah, more to the massage, that's why I didn't want Mom to be in here and you can talk to me about anything. Like I said I interviewed other people already who gave told me what really transpired in that room, I know it's gonna be difficult for you but

FP: We first kind of went there and I gave him a massage and he was just, he was acting like somebody decent, like very nice, and then he kept like staring at me and I'm like, ah, I was giving a massage and then he kept on looking at me and then he's like, oh, you're getting shy and I was like, Yeah, and then he said you feel uncomfortable, and I was like Yeah, a little bit. And then he's like OK. And he said do you want to stop? And I was like No, it's OK. And he's like why are you like deep inside and then I said I don't know and then like, changed the subject and he stopped talking about it and then, ah, and then when we were done he said that if I wanted to come back and see more about it, he would like pay me more and then I was going to talk to [REDACTED] if I wanted to come back.

DJR: OK. What kind of questions did he ask you when you were massaging him?

FP: He asked me about, ah he was asking me if I had any friends that might want to give him a massage and I said I don't know and then he asked me what I wanted to do when I grow up and stuff like that and I asked him if he was going to let me stay with (UI)

DJR: OK. Did he ever ask you how old you were /

FP: No.

DJR: No, did he know that you were 17?

FP: No, I don't think so.

DJR: Or it would've been 16, it was a year ago, right?

FP: Honestly I'm not really sure of anything.

DJR: OK. During the massage, did you, were you naked or....?

FP: No, I wasn't.

DJR: You had all your clothes on?

FP: Hmm, mmm.

DJR: Ah, did he touch in anyway?

FP: He was like kind of leaning towards it but I don't think he (UI) but I heard about other girls like he ah, he made them take off their clothes and stuff.

DJR: OK. That was the first time you went. Right?

FP: Yeah. No, it was the first second time that I gave him a massage. The first time I went I went with [REDACTED].

DJR: So you went upstairs with [REDACTED]?

FP: No, I was in the kitchen.

DJR: You were in the kitchen. You only had two times that you went there.

FP: Yes.

DJR: The first time, you didn't do anything but just sit in the kitchen.

FP: Yeah.

DJR: Who did you sit in the kitchen with?

FP: He had a cook that was there and he had ah, two other girls that worked with him.

DJR: OK. Did you massage his back? Was he naked when you were massaging him?

FP: He had like a towel on. His upper no, but he had like a towel on.

DJR: OK. Did he ever remove that towel?

FP: No.

DJR: When you were massaging him, he never removed the towel.

FP: No.

DJR: OK. Did you, did he have you touch his private area?

FP: No. I wouldn't do that.

DJR: You wouldn't do that. OK. Did he touch you in your private areas?

FP: No. He kept like saying, like I don't know, I (UI) but I heard other stories.

DJR: Right. I'm concerned about you, I know about other stories and I interviewed other people that have told me different things. That's why I'm trying to find out what happened to you. OK?

FP: Hmm, mmm.

DJR: You're the victim on this, so that's why I'm trying to find out what happened to you.

FP: Yeah.

DJR: OK. Ah, did you ever go back to his house?

FP: Well, the time that I told you.

DJR: After that you've never gone back. you've never come back. How much did you receive for the massage?

FP: \$ 200.

DJR: You received \$ 200. OK. Did [REDACTED] explain to you what was gonna be involved?

FP: She said the first time you go there, you pretty much give him a massage but the money (UI)

DJR: That's what scared you?

DMD: She said what you were expecting, she didn't really say....

FP: she didn't say exactly what but ([REDACTED]), she imply, you know taking your clothes off and stuff like that.

FP: No.

DJR: What were you wearing? Can you remember?

DJR: Don't worry. You are not the only person I talked to, OK, there's a lot of people, ah, that I talked to and I'm going to talk to, ah, how did you get to his house?

FP: With [REDACTED].

DJR: [REDACTED] took you the first time and you sat in the kitchen.

FP: Yes.

DJR: What about the second time?

FP: The second time, I drove and she came up to me

DJR: You drove. OK. What did you drive?

FP: Ah, I used to have a Cavalier.

DJR: A Cavalier. What color?

FP: Red.

DJR: OK. Can you describe to me, what does Jeffrey look like? Jeffrey looks like?

FP: Ah, he's tall and then he has white hair, dark hair and he usually wears big glasses, I think (UI)

DJR: OK. When you massage, when you massage him, you massage his back area?

FP: Yes. And I massage his feet too.

DJR: And his feet. Did you do his leg?

FP: Yeah and his calves.
