And we prefer to be in touch directly with counsel from the attorney side [REDACTED] but you should certainly feel free to communicate this to her however you feel would be best.

I just got off the phone with [REDACTED] and she was calling very concerned because she was informed by a media representative [REDACTED] that they had learned the "Mossad" has a "target on her head". [REDACTED] understands that people often say things that don't have credibility but she said this was very concerning to her and she wanted me to check with you and your contacts at the FBI to see if you have heard of this threat? She was also asking if she should try to get some kind of security [REDACTED].
